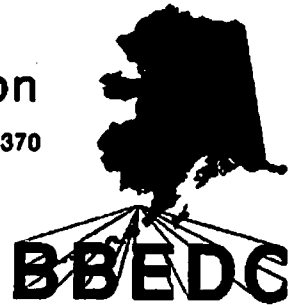

Dear Sirs and Madams:

We make the following comments upon the Preliminary Report to the Local Boundary Commission Concerning the Legislative Review Petition to Annex 396 Square Miles of Water and Three Miles of Islands to the City of Dillingham and Concerning the Legislative Review Petition to Annex 118 Square Miles of Water and 37 Square Miles of Land to the City of Manokotak released by the staff of the Local Boundary Commission on June 3, 2016.

In March of 2011 our Board of Directors representing 17 Coastal Communities in Bristol Bay took a position and adopted a resolution in *opposition* to the City of Dillingham's annexation Petition. More recently we agreed to participate in a joint task force of organizations and communities from throughout the region.

We believe it would be in the state's best interest to allow this local task force reasonable time to prepare a report to the region about borough formation within the Western Bristol Bay Region. The first meeting of this task force was on May 25, 2016. We participated and support the comments that were submitted by the task force that were produced at that meeting.

I am attaching for reference that Task Force's initial letter and comments of June 15th of which we are in full support.

RE: Comments to the Preliminary Report to the Local Boundary Commission

Dear Sirs or Madams:

These comments are in response to the above named report that came out on June 3, 2016 with a comment period that ends July 15, 2016.

The Interim Task Force of the *Regional Government Study with Tribes* project is conducting a borough feasibility study with the Tribes, cities, school districts, and regional organizations in the Dillingham Census Area that will be used for decision making in an intergovernmental consultation at the end of the project. There are eleven communities within the Dillingham Census Area (unorganized borough) that are covered by this project, including Aleknagik, Clarks Point, Dillingham, Ekuk, Ekwok, Manokotak, New Koliganek, New Stuyahok, Portage Creek, Togiak, and Twin Hills. The total population in the Dillingham Census Area is about 5,028 with 3,877 (77%) Alaska Natives. The *Regional Government Study with Tribes* project will provide the information needed for the tribes and cities to make informed decisions regarding borough formation.

The Interim Task Force was formed in October 2014 and BBNA volunteered to raise funds for the project. A Department of Health and Human Services, Administration for Children & Families, Administration for Native Americans, Social and Economic Development Strategies for Alaska (ANA-SEDS-AK) application was submitted March 25, 2015. The City of Dillingham and City of Aleknagik committed to providing \$10,000 and \$4,972.20 respectively to assure the required match for the grant. A grant award was received October 2, 2015. A consulting team was hired and a Task Force was formed. The Task Force had its first meeting on May 25, 2016.

When the project began it was anticipated that the borough feasibility study would be completed by September 30, 2016, so that the information would be available before the Dillingham and Manokotak Petitions moved forward. The Interim Task Force recognized that the potential revenue from a fish tax could help a borough with fiscal needs to maintain and increase services as State and Federal funding declines. Due to project delays, the borough study is now expected to be completed by December 31, 2016.

Over the past 29 years, there have been numerous attempts to form a borough or to annex the Nushagak Bay fishing waters and the result was almost always that some communities felt disenfranchised so no consensus was reached. -The Interim Task Force came together from the need to improve relationships between the communities by building trust and confidence through a borough study process. The smaller communities in the Dillingham Census Area want to engage in the process, but have few resources to draw upon, since there is no road system, and travel between communities is extremely expensive. The ANA-SEDS grant provides for a consulting team, travel, and staff support.

The *Regional Government Study with Tribes* provides a process that includes all the Tribes, cities, school districts, and regional organizations throughout the borough study project to achieve the best outcome with greatest amount of buy-in to support the outcome. The Tribes' participation and being included in the discussion is key to being all inclusive. The challenge is to design a borough that includes and meets the needs of all the communities while remaining feasible, in a timely manner, and in a way that will benefit the City of Dillingham without the further need to annex.

Currently, there are 21 members of the Task Force with three vacant seats. In addition, seven entities have named alternates to the Task Force.
