RESOLUTION NO. 24-0006

A RESOLUTION SUPPORTING THE CITY OF TANANA PETITION TO THE STATE OF ALASKA, DEPARTMENT OF COMMERCE, COMMUNITY AND ECONOMIC DEVELOPMENT, LOCAL BOUNDARY COMMISSION REQUESTING A MUNICIPAL CLASSIFICATION CHANGE

WHEREAS, AS 29.05.011(a)(1) states (a) A community that meets the following standards may incorporate as a first class or home rule city: (1) the community has 400 or more permanent residents;

WHEREAS, the City of Tanana population has fallen under the First Class city required residents to incorporate size of 400;

WHEREAS, according to the recent Census Decennial report the city has 246 residents;

WHEREAS, the city of Tanana **does not** intend to exercise planning, platting, and land use powers under AS 29.35.260(c);


WHEREAS, the City of Tanana requests the Local Boundary Commission, under 3 AAC 110.710 Procedure for reclassification of first class cities with less than 400 residents;_

WHEREAS, the City of Tanana requests to be reclassified from a First Class city to a Second Class city following the procedures outlined in 3 AAC 110.710;

WHEREAS, the City of Tanana has provided the necessary documents outlined in 3 AAC 110.710 for the process to be either approved or denied;

NOW BE IT HEREBY RESOLVED the City of Tanana requests the Local Boundary Commission of the State of Alaska, under 3 AAC 110.710, agree to approve the change of municipal classification from a first class city to a second class city.

On the 27th day of February, 2023, the City of Tanana, City Council voted in the regular meeting that it is in favor of making the change from 1st class City to a 2nd class City.

In the recently passed HB69 it stated that if a City that has a population of less than 400 permanent residents and it submits a written request to the Local Boundary Commission it will be moved from a first class city to a second class city.

The City of Tanana does have a population of less than 400 permanent residents and qualifies for the change under HB69. We formally request through this letter that we be moved to a second class in as expeditious a time a possible.
