Sec. 5. The sum of \$327 is appropriated from the general fund to the Department of Fish and Game for unpaid bills to Service Electric Co., Inc. and to Western Alaska Airlines.

Sec. 6. The sum of \$7,334.27 is appropriated from the general fund to the Department of Health and Social Services for payment of various unpaid bills for medical and other vendors.

Sec. 7. This Act takes effect on the day after its passage and approval or on the day it becomes law without approval.

CHAPTER 41

AN ACT RELATING TO THE BOUNDARIES OF CERTAIN UNITS OF LOCAL GOVERNMENTS IN THE STATE; AND PROVIDING FOR AN EFFECTIVE DATE.

(HCS CSSB 151)

Be it enacted by the Legislature of the State of Alaska:

Section 1. Notwithstanding any other provisions of law, the boundaries of the Greater Anchorage Area Borough are as follows:

Beginning at the N.E. Corner of Sec. 2, T7N, R2E, (projected), Seward Meridian, State of Alaska, said corner being in the Placer River Valley near Spencer; thence East to the N.E. Corner of Sec. 4, T7S, R4E (projected); thence North to the N.E. Corner of Sec. 4, T8N, R4E (projected); thence East to the S.E. Corner of Sec. 33, T9N, R4E (projected); thence North to the S.E. Corner of Sec. 21, T9N, R4E (projected); thence East to the N.E. Corner of Sec. 25, T9N, R5E (projected); thence North to the N.E. Corner of T12N, R5E (projected); thence East to the S.E. Corner of T13N, R5E (projected); thence North to the N.E. Corner of T15N, R5E (projected); thence West to the S.E. Corner of T16N, R1E (projected); thence North to the N.E. Corner of Sec. 25, T16N, R1E (projected); thence West to the S.W. Corner of Sec. 23, T16N, R1E (projected); thence North to the N.E. Corner of Sec. 15, T16N, R1E (projected), said corner being at or approximately at the Alaska Railroad Bridge over the Knik River; thence West to the S.E. Corner of Sec. 12, T16N, R1W (projected), said corner being in Knik Arm, on the Seward Meridian; thence southwesterly to the N.W. Corner of Sec. 13, T15N, R3W (projected), said corner being in Knik Arm at Longitude 149°44'46"W, Latitude 61°23'52"N; thence

southwesterly to the N.E. Corner of Sec. 36, T14N, R4W (projected), said corner being in Knik Arm at Longitude 149°55'31"W, Latitude 61°18'41"N; thence southwesterly to the N.E. Corner of Sec. 16, T13N, R4W (projected), said corner being in Knik Arm at Longitude 149°59'07"W, Latitude 61°13'29"N; thence southwesterly to the N.E. Corner of T12N, R7W (projected), said corner being in Cook Inlet at Longitude 150°26'01"W, Latitude 61°10'01"N; thence southeasterly to the N.E. Corner of T11N, R6W (projected), said corner being in Turnagain Arm at Longitude 150°14'40"W, Latitude 61°04'49"N; thence east to the N.E. Corner of T11N, R5W (projected), said corner being in Turnagain Arm at Longitude 150°04'01"W, Latitude 61°04'49"N; thence southeasterly to the N.E. Corner of Sec. 24, T10N, R2W (projected), said corner being in Turnagain Arm at Longitude 149°32'05"W, Latitude 60°57'01"N; thence southeasterly to the N.E. Corner of T9N, R1W (projected), said corner being in Turnagain Arm, at Longitude 149°21'26"W, Latitude 60°54'25"N; thence east to the N.E. Corner of T9N, R1E (projected), said corner being in Turnagain Arm at Longitude 149°10'48" West, Latitude 60°54'25" North, thence southeasterly to the N.E. Corner of Sec. 15, T9N, R2E (projected), said corner being in Turnagain Arm at Longitude 149°03'41"W, Latitude 60°52'41"N; thence southerly to the N.E. Corner of Sec. 26, T9N, R2E (projected), said corner being in Turnagain Arm at Longitude 149°01'55"W, Latitude 60°50'57"N; thence South to the S.E. Corner of Sec. 35, T9N, R2E (projected); thence West to the N.E. Corner of Sec. 2, T8N, R2E (projected); thence South to the place of beginning.

Sec. 2. Notwithstanding any other provision of law, the boundaries of the City of Anchorage are as follows:

Beginning at the southeast corner of Section 15, Township 13 North, Range 3 West, Seward Meridian, Alaska; thence along the section line common to Sections 14 and 23, S89° 58' E 2475.33 feet, more or less, to the intersection of said section line with the southerly extension of the west line of Lot 2, Markstrom Subdivision, as shown on the official recorded plat of said subdivision on file in the Anchorage District Recorder's Office (File Number P-570); thence along the west line of said Markstrom Subdivision and its extension N 0° 03' 20" E 350.0 feet, more or less, to the northwest corner of the Markstrom Subdivision; thence along the north line of the Markstrom Subdivision and its extension, S 89° 58' E 164.04 feet, more or less, to the north-south centerline of Section 14; thence along the north-south centerline of Section 14, N 0° 02' 30" W 2290.0 feet, more or less, to the center 1/4 corner of Section 14; thence along the east-west centerline of Section 14, N 89° 53' W 2640.32 feet, more or less, to the 1/4 corner common to Sections 14 and 15; thence along the east-west centerline of Section 15, N 89° 59' 30" W 1340.25 feet, to a point; thence N 0° 03' 47" E 30.0 feet, to the southeast Corner of Lot 23.
