CERTIFICATE

BOUNDARIES OF THE CITY OF ALAKANUK

I, LEE McANERNEY, Commissioner of the Alaska Department of Community and Regional Affairs, do hereby certify that the local government boundary change detailed below became effective on June 10, 1981.

On February 3, 1981, the City of Alakanuk submitted to the Alaska Department of Community and Regional Affairs, a petition for annexation pursuant to 19 AAC 15.010-130. The petition requested annexation of Sections 1, 2, 3, 4, 5, 6, 8, 12, 17, 32 and 33, T30N, R82W, Seward Meridian; Sections 5, 6, 7 and 8, T30N, R81W, S.M.; Sections 31, 32, 33 and 34, T31N, R82W, S.M.; and those portions of Sections 9, 10, 11, 13, 14, 16, 20, 21, 25, 27, 28, 29, 34, 35 and 36, T30N, R82W, S.M. and Sections 18, 19 and 30, T30N, R81W, S.M.; not within the existing corporate limits of the City of Alakanuk.

The Department of Community and Regional Affairs reviewed the petition and supporting documentation, and determined that all was in proper form and contained the necessary information.

The Local Boundary Commission reviewed and approved the petition as submitted on March 25, 1981.

Pursuant to 19 AAC 15.080, an election was held on June 2, 1981; 28 qualified votes were cast in favor of annexation and 2 qualified votes were cast against. The annexation became effective June 10, 1981, pursuant to 19 AAC 15.130.


The post annexation boundaries of the City of Alakanuk, are described as follows:

Beginning at the protracted NE corner of Section 5, T30N, R81W, Seward Meridian; thence west to the protracted NW corner of Section 2, T30N, R82W, S.M.; thence north to the protracted NE corner of Section 34, T31N, R82W, S.M.; thence west to the protracted NW corner of Section 31, T31N, R82W, S.M.; thence south to the protracted SW corner of Section 6, T30N, R82W, S.M.; thence east to the protracted SE corner of Section 6, T30N, R82W, S.M.; thence south to the protracted SW corner of Section 32, T30N, R82W, S.M.; thence east to the protracted SE corner of Section 36, T30N, R82W, S.M.; thence north to the protracted NE corner of Section 36, T30N, R82W, S.M.;

thence east to the protracted SE corner of Section 30, T30N, R81W, S.M.; thence north to the protracted NE corner of Section 18, T30N, R81W, S.M.; thence east to the protracted SE corner of Section 8, T30N, R81W, S.M.; thence north to the protracted NE corner of Section 5, T30N, R81W, S.M.; the point of beginning, containing 42 square miles, more or less.
