ORDER OF INCORPORATION

At this time the Court considers the records and files from which it appears and the Court finds that a petition was duly filed in this Court and signed by at least 10 bona fide residents 21 years of age or older of the community of FORT YUKON in the Fourth Judicial Division of the State of Alaska praying that the community be incorporated as a village pursuant to the provisions of Chapter 150, SLA 1957.

Order was then made for a Public Hearing and that order duly posted in 3 public places in the village.

That a public Hearing was held in the community on the subject of incorporation; that upon such hearing this Court made its order finding that it is for the best interest and welfare of the above entitled village that it become incorporated.

The Court did fix the time for the holding of an election to determine wheter a majority of the qualified electors of said community desired to become incorporated as a village and did appoint 3 qualified voters as Election Judges.

That copies of the election notice were posted in 3 public places within the proposed village.

That pursuant to said notice an election was duly held on the 11th day of February, 1959, and the Election Judges have sent to this Court their returns and certification.

That at said election and by a separate ballot the electors cast their ballots for the election of 5 persons to serve as councilmen of said village; that it appeared from the return of the election judges that the following named persons received the highest number of votes as councilmen: WALTER HANNUM

ISAAC FIELDS HANNAH SOLOMON MARDOW SOLOMON OLIVER MARSON

That all matters and things required to be done and observed have been done and performed pursuant to the provisions of Chapter 150, SLA 1957.

And now, the Court being fully advised and having found as aforesaid:

DOES ORDER, ADJUDGE AND DECREE that the "Incorporated Village of FORT YUKON," situated and existing in the Fourth Division of the State of Alaska, now is and henceforth shall continue to be a duly incorporated village, pursuant to the provisions of Chapter 150, SLA 1957 and shall enjoy and possess all the rights, powers, and privileges granted by Chapter 150, SLA 1957; That the boundaries of said incorporated village shall be as follows: Starting with Joe Wards slough located on the West end of Fort Yukon, Alaska, thence down stream, Yukon River, to the Upper Mouth of the Porcupine River following the North Bank down stream thence up the Porcupine River following the right hand bank and stopping at the Mourth of Sucker River, approximately seven miles from the starting point of Joe Wards slough. Thence: upstream on the Sucker River, following the right bank approximately four miles and stopping at Laura Lake. Thence: from Laura Lake, a direct line, approximately one and one half miles, running in a South direction to the Northeast corner of the local military reservation which is located East of Fort Yukon, Alaska. Following the military reservation border on the North and West sides down to the Yllota Slough. Thence: following the Yllota Slough down stream approximately three quarters mile to the Yukon River, following the Right bank, continuing down stream, following the right bank approximately one mile to the starting point at Joe Wards Slough;

That the village is declared a body politic under the name of the "Incorporated Village of FORT YUKON;

That said incorporated village shall have perpetual succession by such corporate name;

That said incorporated village is empowered to hold personal and real property necessary for its purposes;

That said incorporated village is empowered to sue and be sued; That said incorporated village is empowered to make and amend

ordinances, ruled, regulation, and orders in accordance with law; That said incorporated village is empowered to do such other

acts necessary or desirable to carry its powers into effect.

 FURTHER, it is ORDERED, ADJUDGED AND DECREED that

 be and they are hereby declared to be the duly elected councilmen of

 the "Incorporated Village of FORT YUKON" and are entitled to hold such

 until one year from this date, or until their successors are elected

 and qualified.
