
RE: JURISDICTIONAL BOUNDARIES OF THE CITY OF GALENA, ALASKA

I, Emil Notti, Commissioner of the Department of Community and Regional Affairs, hereby certify that the following is a true and accurate description of the boundaries of the City of Galena, Alaska. I certify further that the territory within the boundaries described below has been made a part of the jurisdiction of the City of Galena, Alaska, in accordance with the applicable laws and regulations of the State of Alaska. The boundaries described below include the annexation of approximately 480 acres of land which was effected April 23, 1985.

Beginning at the NW corner of Section 35, Unsurveyed T8S, R9E, Kateel River Meridian (K.R.M.); thence S to the SW corner of Section 35, Unsurveyed T8S, R9E, K.R.M.; thence E to the NW corner of Section 1, Unsurveyed T9S, R9E, K.R.M.; thence S to the SW corner of Section 12, Unsurveyed T9S, R9E, K.R.M.; thence E to the SE corner of Section 7, Unsurveyed T9S, R11E, K.R.M.; thence N to the NE corner of Section 6, Unsurveyed T9S, R11E, K.R.M.; thence W to the SE corner of Section 36, Unsurveyed T8S, R10E, K.R.M.; thence N to the NE corner of Section 36, Unsurveyed T8S, R10E, K.R.M.; thence W to the SE corner of the SW 1/4 of Section 28, Unsurveyed T8S, R10E, K.R.M.; thence N to the NE corner of the S1/2 of the NW1/4 of Section 28, Unsurveyed T8S, R10E, K.R.M.; thence W to the NW corner of the S1/2 of the NE1/4 of Section 29, Unsurveyed T8S, R10E, K.R.M.; thence S to the SW corner of the SE1/4 of Section 29, Unsurveyed T8S, R10E, K.R.M.; thence W to the point of beginning.

Containing approximately 24.75 square miles, all in the Fourth Judicial District, State of Alaska.
