CERTIFICATE

I, ROBERT W. WARD, LIEUTENANT GOVERNOR OF THE STATE OF ALASKA, DO HEREBY CERTIFY THAT, in accordance with the provisions of AS 29.10.022, an election for the incorporation of a fourth class city known as Koyuk, Alaska, was held on October 6, 1970, within the boundaries of said proposed area for incorporation and that a majority of votes were cast for incorporation. The vote was 34 for and 6 against.

AND THAT a majority of the votes were cast for enactment of a 2% sales tax. The vote was 30 for and 11 against.

I DO FURTHER CERTIFY THAT the city of Koyuk is incorporated as a fourth class city;

THAT it possesses all the powers and privileges prescribed for cities of the fourth class by Title 29 of the ALASKA STATUTES:

THAT the boundaries of the said city are:

Beginning at the point where the West boundary of Section 31, Township 6 South, Range 12 West, projected, Kateel River Meridian, Alaska, intersects the mean low water line of the westerly bank of the Koyuk Inlet; thence due North approximately 2 1/4 miles to the quarter section point of the West boundary of Section 19, Township 6 South, Range 12 West; thence due East approximately 3 miles to the quarter section point of the East boundary of Section 21, Township 6 South, Range 12 West; thence due South approximately 1 3/4 miles to the point where the East boundary of Section 33, Township 6 South, Range 12 West, intersects the mean low water line of the northerly bank of the Koyuk Inlet; thence in a general westerly direction approximately 3 miles along the mean low water line of the Koyuk Inlet to the point of beginning being an area containing 5 square miles, more or less.

AND THAT on October 6, 1970, the following were elected as councilmen on the initial city council:

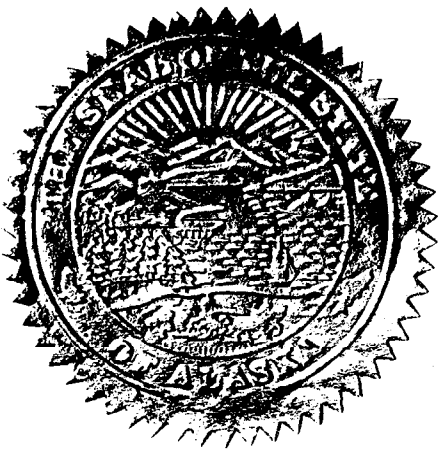

AND THAT the term of this office is to be one year unless determined otherwise by the city council.

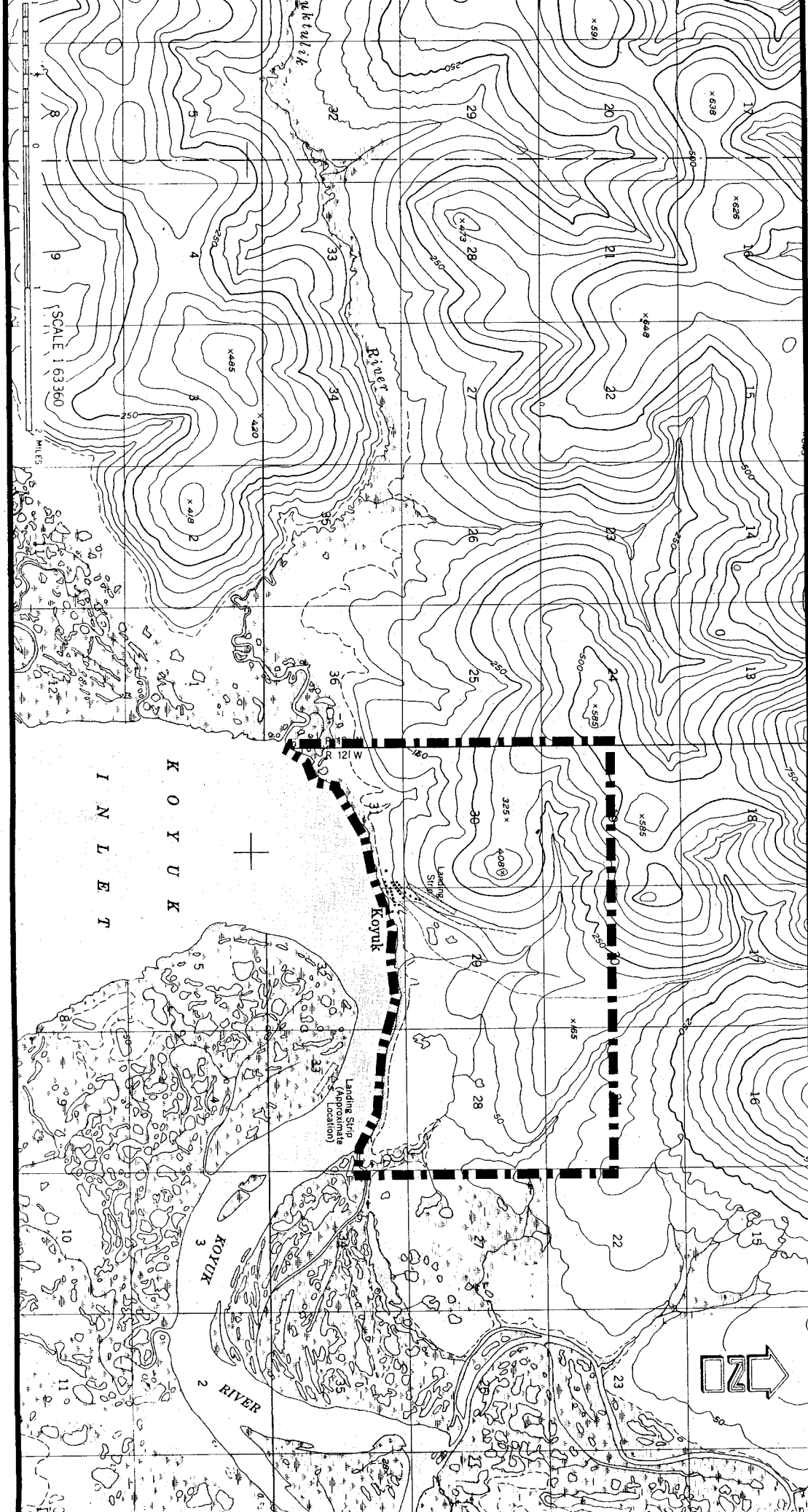
