CERTIFICATION OF BOUNDARIES

CITY OF LOWER KALSKAG

I, SIGVALD J. STRANDBERG, Acting Director of the Local Affairs Agency, Office of the Governor, State of Alaska, do hereby certify that the attached recommendation for a local government boundary change entitled

Recommendation for Correcting an Error
in the Present Description of the Boundaries
of the City of Lower Kalskag

became effective on March 8, 1970.

A PETITION requesting the incorporation of the village of Lower Kalskag as a fourth class city was received by the Local Affairs Agency on May 5, 1969. After investigation of the petition by the agency, the Local Boundary Commission called for and held a public hearing in Lower Kalskag on June 9, 1969. On June 21, 1969, the Commission held a formal business meeting in Fairbanks, Alaska and voted to accept the petition with a modification of the boundaries. An election was held at Lower Kalskag on August 12, 1969 at which time the citizens voted 29 to 0 for incorporation. The election was certified by the Secretary of State on August 27, 1969.

On September 5, 1969, the agency directed a letter to the Council of Lower Kalskag calling their attention to a typographical error in the City of Lower Kalskag boundary description and requested their comments. No written objections were received from the Council of Lower Kalskag. On January 4, 1970, the Local Boundary Commission held a formal business meeting in Anchorage, Alaska and voted to recommend to the legislature a new boundary description correcting the error.

THE COMMISSION'S recommendation was presented to the state legislature pursuant to Section 12, Article X of the Constitution of the State of Alaska:

Section 12. Boundaries. A local boundary commission or board shall be established by law in the executive branch of the state government. The commission or board may consider any proposed local government boundary change. It may present proposed changes to the legislature during the first ten days of any regular session. The change shall become effective forty-five days after presentation or at the end of the session, whichever is earlier, unless disapproved by a resolution concurred in by a majority of the members of each house. . .

THE SECOND SESSION of the Sixth State Legislature received the Commission's recommendation on January 21, 1970, the tenth day of the legislative session. No resolutions requesting legislative disapproval of the Commission's recommendation were introduced. The Local Boundary Commission's "Recommendation for Correcting an Error in the Present Description of the Boundaries of the City of Lower Kalskag" became effective on March 8, 1970, the forty-sixth day after its presentation to the legislature. The boundaries of the City of Lower Kalskag are now, therefore, as described in the Local Boundary Commission's recommendation, to wit:

Commencing at the Southeast corner of the Northwest one-quarter of Section 2, T16N, R62W, Seward Meridian, Alaska,

Corner No. 1, the point of beginning;
thence North 0.5 miles to
Corner No. 2; thence East 0.5 miles to
Corner No. 3; thence North 1.0 miles to
Corner No. 4; thence West 1.0 miles to
Corner No. 5; thence South 0.5 miles to
Corner No. 6; thence West 0.5 miles to
Corner No. 7; thence South 1.0 miles to
Corner No. 8; thence East 1.0 miles to
Corner No. 1, the point of beginning, and
Containing 1120 acres.
