I, JOHN R. BEARD, Director of the Local Affairs Agency, Office of the Governor, State of Alaska, do hereby certify that the attached recommendation for a local government boundary change entitled

Recommendation for Changing the Boundaries of the City of Nenana became effective on March 23, 1969.

A PETITION requesting the annexation of an area lying south and west of the City of Nenana was submitted by the City of Nenana and received by the Local Affairs Agency on December 30, 1968. After investigation of the petition by the agency, the Boundary Commission called for and held a public hearing at Nenana on February 1, 1969. Immediately following the hearing, the commission held a business meeting at which it voted to accept the petition and to recommend to the legislature the boundary change presented therein.

THE COMMISSION'S recommendation was presented to the state legislature pursuant to Section 12, Article X of the Constitution of the State of Alaska:

Section 12. Boundaries. A local boundary commission or board shall be established by law in the executive branch of the state government. The commission or board may consider any proposed local government boundary change. It may present proposed changes to the legislature during the first ten days of any regular session. The change shall become effective forty-five days after presentation or at the end of the session, whichever is earlier, unless disapproved by a resolution concurred in by a majority of the members of each house. The commission or board, subject to law, may establish procedures whereby boundaries may be adjusted by local action.

THE FIRST SESSION of the sixth state Legislature

received the Commission recommendation on February 5, 1969, the 5th day of the legislative session. Senate Joint Resolution #13, which requested legislative disapproval of the Commission recommendation, was introduced on February 11, 1969. This resolution was not adopted. The Local Boundary Commission's "Recommendation for Changing the Boundaries of the City of Nenana" became effective on March 23, 1969, the 46th day after its presentation to the legislature. The boundaries of the City of Nenana are now, therefore, as described in the Local Boundary Commission recommendation, to wit:

From the point of Beginning, which is the Southeast Corner of Section Thirty-Six (36), Township Four (4) South, Range Eight (8) West, Fairbanks Meridian, go Northerly along the Township Line to the Point in Section 24, Township 4 South, Range 8 West, Fairbanks Meridian, where the Township line intersects the Southerly Bank of the Tanana River; thence Meandering along the Southerly bank of the Tanana River in a Northwesterly, Westerly and Southwesterly direction to the confluence of the Tanana River and the Nenana River; thence meandering along the Easterly Bank of the Nenana River, in a Southwesterly, Southerly, Southeasterly, Westerly, Northwesterly, Easterly and Northeasterly direction to the intersection of the Easterly bank of the Nenana River with the Southerly Township line of Township 4 South, Range 8 West, Fairbanks Meridian, which intersection is located in Section 34, Township 4 South, Range 8 West, Fairbanks Meridian; thence East along the South Township line of Township 4 South, Range 8 West, Fairbanks Meridian, to the Southeast corner of Section 36, Township 4 South, Range 8 West, Fairbanks Meridian, the point of beginning.
