THAT it possesses all the powers and privileges prescribed for cities of the second class by Title 29 of the Alaska Statutes;

THAT the boundaries of the said city are:

Beginning at the SE corner of Unsurveyed T8S, R47W, Seward Meridian, Alaska; thence North to the NE corner of Unsurveyed T8S, R47W; thence West to the NW corner of Unsurveyed T8S, R47W; thence South to the SW corner of Unsurveyed T8S, R47W; thence Fest to the point of beginning, containing 36 square miles, more or less.


