

CERTIFICATE

I, H. A. BOUCHER, LIEUTENANT GOVERNOR OF THE STATE OF ALASKA, DO HEREBY CERTIFY THAT, in accordance with the provisions of AS 29.10.022, an election for the incorporation of a fourth class city known as Nondalton, Alaska, was held on March 2, 1971, within the boundaries of said proposed area for incorporation and that a majority of votes were cast for incorporation. The vote was 36 for and 0 against.

AND THAT a majority of votes were cast for enactment of a 3% sales tax. The vote was 23 for and 13 against.

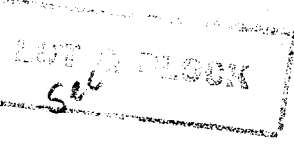
I DO FURTHER CERTIFY THAT the city of Nondalton is incorporated as a fourth class city with authority to enact a 3% sales tax;

I DO FURTHER CERTIFY THAT the city of Nondalton is incorporated as a fourth class city;

THAT it possesses all the powers and privileges prescribed for cities of the fourth class by Title 29 of the ALASKA STATUTES;

THAT the boundaries of the said city are:

Beginning at the NW corner of Section 24, T2S, R33W, Seward Meridian Alaska as projected; thence South to the SW corner of Section 1, T3S, R33W; thence East to a point on the center of the South boundary of Section 6, T3S, R32W; thence North along the center line of Section 6, T3S, R32W; to a point at the center of the North boundary of Section 6, T3S, R32W; thence West to the NW corner of Section 6, T3S, R32W; thence North to a point where the West boundary of Section 31, T2S, R32W, intersects the meander of Six-mile Lake; thence in a northerly and easterly direction along the meanders of Sixmile Lake to a point where the North boundary of Section 20, T2S, R32W, intersects the meander of Sixmile Lake; thence West to the point of beginning, containing 7.0 square miles, more or less.



AND THAT on March 2, 1971, the following were elected as councilmen on the initial city council;

AND THAT the term of this office is to be one year unless determined otherwise by the city council.

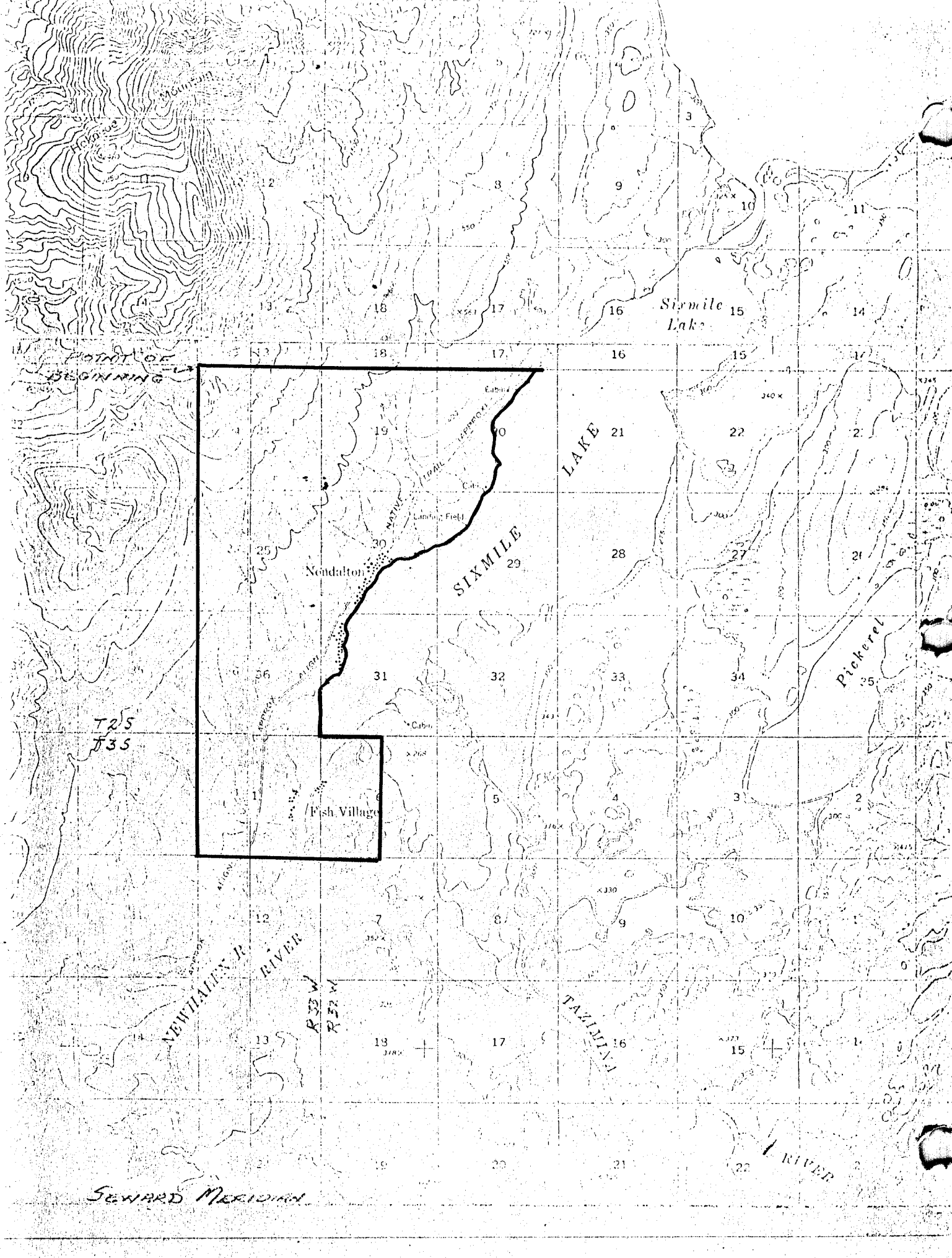
