I, LEE McANERNEY, COMMISSIONER of the Department of Community and Regional Affairs, do hereby certify that the Local Boundary Commission recommendation entitled.

Recommendation to Correct the Boundary  
Description of the City of Nuiqsut, Alaska

became effective on March 4, 1976.

A certificate of incorporation for the City of Nuiqsut, a city of the second class, was issued by the Lieutenant Governor pursuant to AS 29.18.120. on June 24, 1975. In transcribing the boundary description of the City of Nuiqsut from the Local Boundary Commission's order, an administrative error was made to wit: The direction "thence 3 miles West;" was omitted.

The Local Boundary Commission has determined that the error is of a ministerial rather than of a decisional nature.

A majority of the members of the Commission voted to recommend to the Legislature the boundary corrected description.

THE COMMISSIONER'S recommendation was presented to the State Legislature pursuant to Article X Section 12 of the Constitution of the State of Alaska.

THE SECOND SESSION of the Ninth State Legislature received the Commission's recommendation on January 19, 1976; the second

day of the legislative session. No resolution of disapproval was introduced.

THEREFORE, the Local Boundary Commission's "Recommendation for correction of the boundary description for the City of Nuiqsut, Alaska" became effective on March 4, 1976, the forty-sixth day after presentation to the Legislature. The boundary description of the City of Nuiqsut is as described in the Local Boundary Commission's recommendation to wit:

City of Nuiqsut

Beginning at the SE Corner of the NE 1/4 of unsurveyed T10N, R4E, Umiat Meridian, Alaska; thence East 1 1/2 miles to the point of beginning; thence 1 1/2 miles North; thence 3 miles West; thence 3 miles South; thence 3 miles East; thence 1 1/2 miles North to the point of beginning containing 9 square miles more or less.

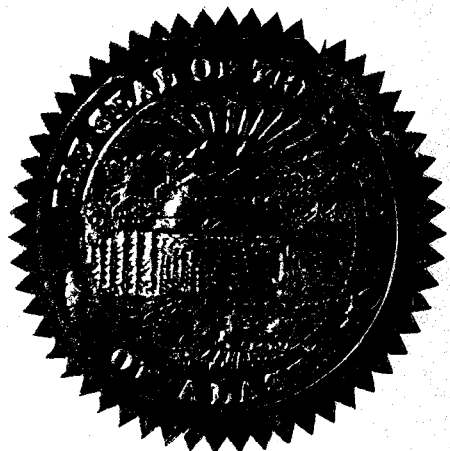

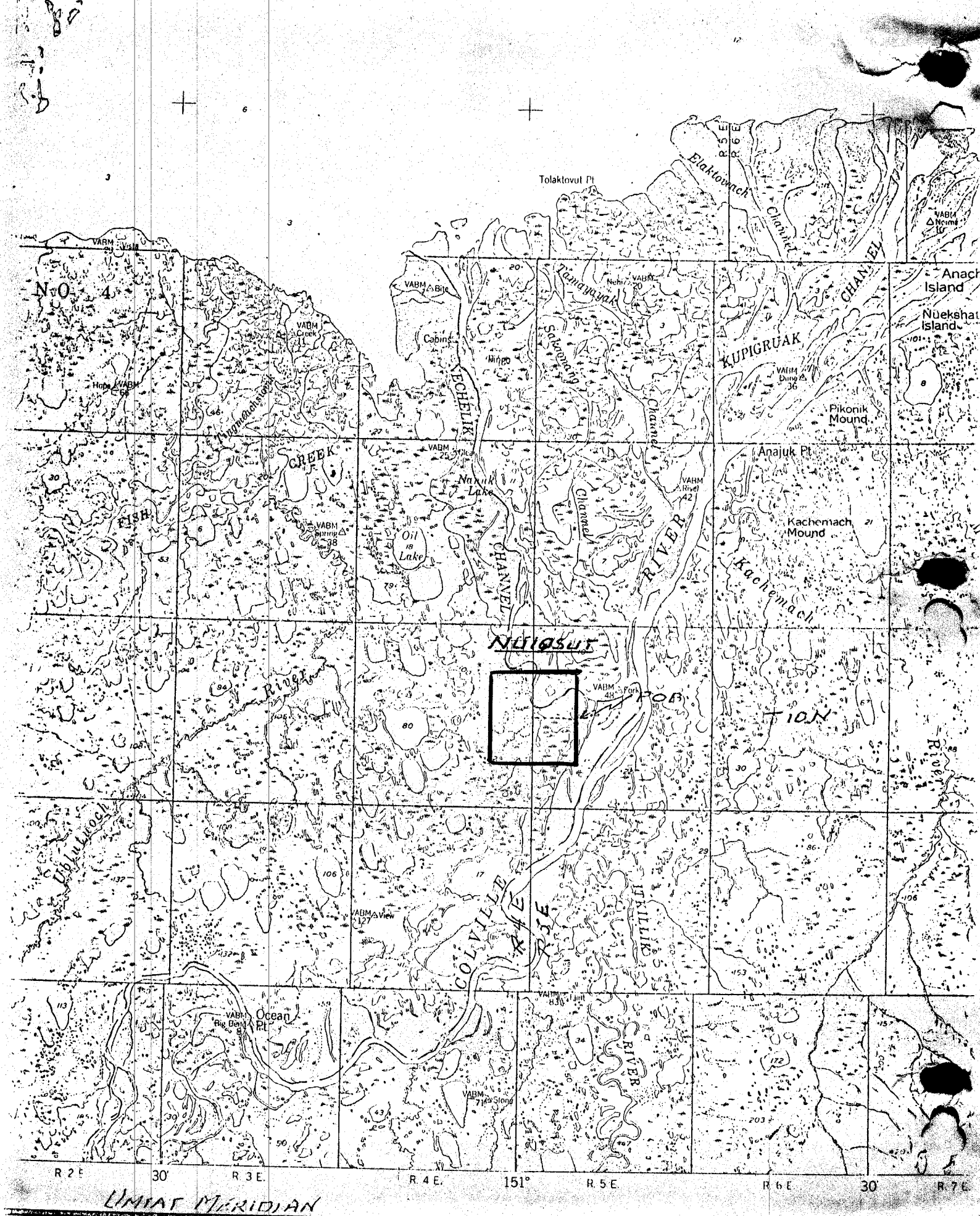
