CERTIFICATE

I, ROBERT W. WARD, SECRETARY OF STATE OF THE STATE OF ALASKA, DO HEREBY CERTIFY THAT, in accordance with the provisions of AS 29.10.022 an election for the incorporation of a fourth class city known as Shaktoolik, Alaska, was held on September 23, 1969, within the boundaries of said proposed area for incorporation and that a majority of votes were cast for incorporation. The vote was 30 for and 1 against.

AND THAT a majority of the votes were cast for enactment of a 2% sales tax. The vote was 22 for and 9 against.

I DO FURTHER CERTIFY THAT the city of Shaktoolik is incorporated as a fourth class city with authority to enact a 2% sales tax;

THAT it possesses all the powers and privileges prescribed for cities of the fourth class by Title 29 of the ALASKA STATUTES;

THAT the boundaries of the said city are:

Beginning at meander Corner No. 3 of U.S. Survey No. 3779, Alaska; thence South 52°55'W, to meander Corner No. 4 of U.S. Survey No. 3779, Alaska; thence in a northwesterly direction along the meander of Norton Sound, a distance of 5.0 miles, more or less; thence in an easterly direction, a distance of 500 feet, more or less, along the meander of the outlet of Shaktoolik Bay; thence in a southeasterly direction along the meander of Shaktoolik Bay, and the meander of the Tagoomenik River, a distance of 5.0 miles, more or less, to meander Corner No. 3 of U.S. Survey No. 3779, Alaska, which is the point of the beginning.

AND THAT on September 23, 1969, the following were elected as councilmen on the initial city council:

- Simon Bekoalok
- Edward Sagoonick
- Palmer Sagoonick
- Lucy Sockpealuk
- Clara Sookiayak


AND THAT the term of this office is to be one year unless determined otherwise by the city council.
