AFFIDAVIT OF MEILANI SCHIJVENS

I, MEILANI SCHIJVENS, being first duly sworn, do depose and say that:


- 1. I am owner and Director of Rain Coast Data, a Juneau-based research and consulting firm. I have dedicated my 25-year professional career to Alaska economic and community development, specializing in Southeast Alaska economic analysis, publications, socioeconomic impact studies, survey research, and public outreach. I have authored hundreds of Alaska economic studies. My clients primarily consist of cities, boroughs, tribes, other governmental entities, and nonprofit organizations. Examples include the 2025 5-year Comprehensive Economic Development Strategy (CEDS) for Southeast Alaska, and Southeast Alaska by the Numbers.
- 2. I have been asked to give an opinion as to whether there is specific and persuasive evidence as to whether the population of the proposed Xunaa Borough is large and stable enough to support borough government. It is my opinion that there is specific and persuasive evidence that, due to the sustained growth of the Hoonah economy since 2010, along with evidence that the economy will continue to prosper and expand into the future, the population of the proposed Xunaa Borough is large and stable enough to support borough government. This affidavit sets out the basis for that opinion.
- 3. I hold a Master of Science from the University of Oregon and a Bachelor of Arts History from Colby College. My resume is attached.
- 4. In addition to my 9 years at Rain Coast Data, I was the Executive Director at Southeast Conference, taught Alaska Economic History at the University of Oregon, worked as a Research Analyst at McDowell Group, worked as a Legislative Research Analyst for the State of Alaska, served as a staffer to the US Legislative Minority Leader in Washington DC., and worked at the Juneau Economic Development Council.
- 5. In 2022, I was engaged by the Sustainable Southeast Partnership to support industry opportunity and community capacity assessments for Yakutat, Pelican, Hoonah, Angoon, Kake, and Prince of Wales. As part of that process, I conducted community economic analyses, including *Hoonah by the Numbers 2022*.
- 6. My opinion is based on five key economic indicators, including the growth of the visitor sector, demographic trends, decreasing unemployment, business climate, and school enrollment:

a. Past and forecasted growth of visitation to Icy Straight Point as a tourist destination

In 1996, a tribal-private-public partnership was developed that would change the trajectory of Hoonah's long-term growth. Huna Totem bought the Hoonah cannery, originally built in 1912, converting it and the surrounding property into a cruise ship destination. Icy Strait Point welcomed its first cruise ship in 2004. The proximity of Icy Strait Point to the community offered new sources of employment and local business opportunities in the form of retail, food and beverage services, shore-excursions, and transportation. Between 2007 and 2022, two cruise ship docks, a zip-line, and two gondolas were installed at the site. Arriving passenger numbers more than doubled between 2013 and 2019 and are expected to nearly double again between 2019 and 2023 to more than a half million visitors. While the cruise season was cancelled in 2020, and reduced by 90% of normal in 2021, the sector had fully recovered by 2022.

In 2023, arriving passengers in Hoonah are expected to spend \$52 million in the community.² Hoonah's city sales tax is 6.5% and the city receives a portion of the State-collected Commercial Passenger Vessel Excise Tax, while Huna Totem collects additional revenue. In 2023, the last ship will depart Hoonah on October 26. By 2024, the first ship will arrive April 1, meaning the tourism season has been extended to a full seven months allowing the sector to attract year-round businesses and residents.

Hoonah Arriving Cruise Ship Passengers





b. Long-term demographic trends

An analysis of long-term Alaska Department of Labor trends of the proposed Xunaa Borough shows that between 2009 and 2019, the population grew by 23%, or by 183 individuals.³ The growth can primarily be attributed to the growth of Icy Strait Point, leading to increased economic opportunities in the area. The pandemic caused a year of no tourism (2020) and a year of 10% tourism levels (2021); however, between 2021 and 2022, the population of the proposed borough grew by 1.9%, even though every other borough in Southeast Alaska lost population.

Due to the strength of economic projections, the proposed Xunaa Borough should exceed 1,000 residents by 2024. The linear projection model shows the area exceeding 1,000 residents even earlier.



c. Long-term unemployment trends

The unemployment rate for Hoonah is measured as part of the larger Hoonah-Angoon Census Area. The annual unemployment rate for the area dropped from 15.4% in 2011 by more than half to 7.3% in 2022. The August 2022 unemployment rate of 3.6% was the lowest on record for any month in the history of the census area (a change in the way labor force statistics are calculated for sub-state areas makes data prior to 2010 not comparable with later data.)⁴ The decreasing unemployment rate is due to increasing jobs and employment opporutnities in the community of Hoonah. The unemployemnt rate increase in 2020 was due to the arrival of zero large cruise ships in 2020, along with additonal COVID-19 related closures. The unemployment rate is expected to continue to decrease as local job growth will require attracting workers from outside the Hoonah area, which will lead to increased population.

d. 2022 business climate analysis


Each year Rain Coast Data conducts a regional business climate survey to track Southeast Alaska business confidence. In 2022, 14 Hoonah business owners and operators responded to the survey, representing 70 workers. Survey analysis for Hoonah includes the following findings:

- Strong Business Climate: Nearly threequarters (71%) of Hoonah business leaders had a positive view of the business climate in 2022, one of the best business climate reports in the region.
- Outlook is Brightest in Region: Half of respondents expected their prospects to be "much better" in 2022-2023, the <u>best</u> <u>economic outlook</u> for any community in the Southeast Alaska region.
- **Businesses are Hiring:** More than a fifth (21%) of Hoonah businesses were in hiring mode and expected to add employees.
- Top Business Barriers and Benefits: Local elements that are most considered benefits to businesses in Hoonah include recreation, culture, arts, and overall quality of life. The most significant business barriers include the cost of energy, construction, and business overall; along with the lack of housing availability.


Comments from Hoonah Business Leaders about the economy include the following:

- "I think our business is going to thrive this next couple of years and that we'll grow if things to continue like so."
- "We are very optimistic for this 2022 season. We are seeing 100 plus % increases on pre-booked tours when compared to the same periods in 2019."

2022 Hoonah Alaska: What is the economic outlook for your business/industry over the next year (compared to the previous year)?



e. School Enrollment Growth

Not only is the community growing, but the youth population is also growing. In the past 12 years, enrollment in Hoonah schools has increased six times, growing from 106 students in 2010 to 122 students in 2020-2021 school year, for overall growth of 15%.⁵ Regionwide, total student population decreased by 9% over the same period across Southeast Alaska as a whole. A linear trend analysis indicates continued K-12th grade enrollment increases in Hoonah.

7. Finally, my assessment that the population of the proposed Xunaa Borough will continue to grow moving forward comes from the business philosophy espoused by Huna Totem itself. In 2000, I was invited to Hoonah to see the new port concept. I walked along an empty beach and through a crumbling cannery and was told that one day it would host restaurants and shops staffed by local residents, have boardwalks, bookstores, traditional dancers, and space for a fleet of charter boats to bring visitors fishing and whale watching. The campus development stayed true to that original vision. At a speech at Southeast Conference on February 1, 2023, President and Chief Executive Officer of Huna Totem Corporation Russell Dick stated: "We integrate the values of our community into our port, and not the other way around." Such a philosophy points to a long-term model of success that will lead to continued community growth.
