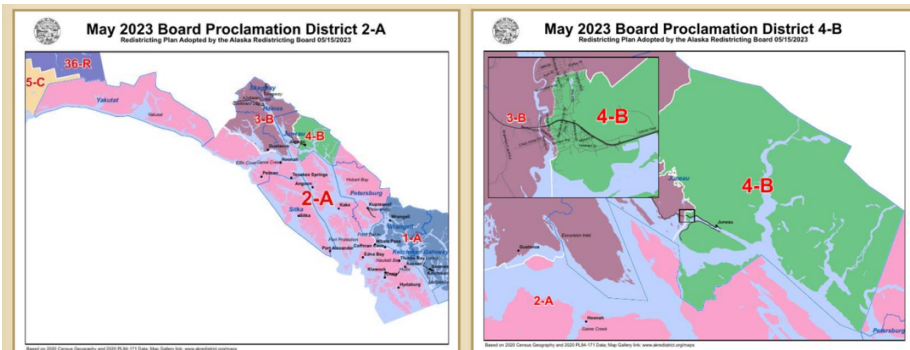
To the Alaska Boundary Commission:

We are property owners on Horse and Colt islands and write this letter in support of the City of Hoonah's petition to the Alaska Boundary Commission to become the Xunaa Borough. This petition proposes boundaries that include Horse and Colt islands, along with the Mansfield Peninsula (Funter Bay).

Many Horse and Colt residents purchased their unincorporated property largely because they did not want to be in an organized borough that could subject them to taxation without representation or services. Many residents also chose Horse and Colt because they desired closer access to Icy Strait fishing, and hunting opportunities on Admiralty Island and other nearby Southeast island locales. A few of our island families have familial ties to Hoonah and surrounding indigenous areas.

Geographically and culturally, we believe our properties have much in common with the rural nature of the proposed Xunaa Borough. This is evidenced by the inclusion of the areas proposed for annexation in Alaska House District 2-A, which includes Hoonah and most of the other island communities. For a place to be included in a House District, Article VI, Section 6 of Alaska's Constitution requires that a District ". . . shall be formed of contiguous and compact territory containing as nearly as practicable a relatively integrated socio-economic area."

These boundaries are based on official U.S. Census data and must coincide with official census blocks. The current District boundaries were challenged but ultimately approved by the Alaska Supreme Court, establishing that the designated district meets the socio-economic legal requirements.



The City and Borough of Juneau (CBJ) Assembly recently filed an objection to the Xunaa Borough petition and boundary plan. Presumably, CBJ continues to desire annexation of these remote properties for purposes of taxation but has offered no reciprocal services in return, nor any explanation of why the proposed area would be a better socio-economic fit with Juneau. Our island residents are near-unanimously opposed to annexation by Juneau. That sentiment was previously demonstrated during CBJ Assembly meetings in 2006 and 2019 when Horse and Colt annexation was discussed.

In the understanding that all unincorporated areas in the State will eventually come within some borough, we the undersigned residents of Horse and Colt Islands hereby express our strong support for the petition by the City of Hoonah for creation of the Xunaa Borough with boundaries to include our remote homesites. This letter represents the collective view of approximately 68 property owners and residents. Documentation of their approval can be provided upon request.
