# Grant



- Can be competitive application processes
- Detailed proposals
- Restricted funding
- Detailed reporting
- Example
  - Community Development Block Grant



## Grant vs. Revenue Sharing

DEPARTMENT OF COMMERCE, COMMUNITY, AND ECONOMIC DEVELOPMENT

- Broader distribution of funding based on shared revenue stream
- Wider range of needs within a general area.
- Unrestricted funding
- Allocating funds based on a formula with fewer application requirements.

# Community Assistant Program – Revenue Sharing

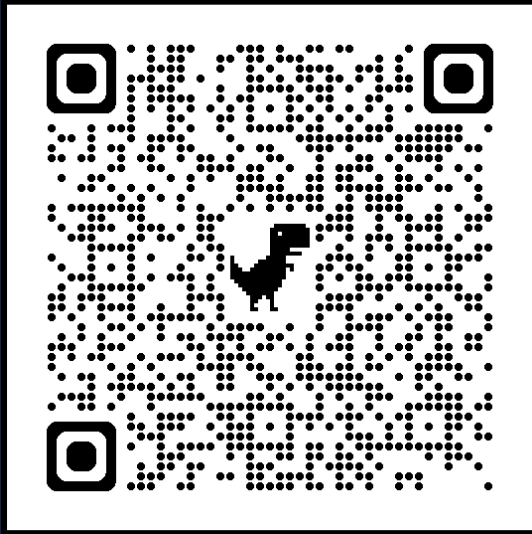
- Originally called the Community Revenue Sharing – renamed in FY2016
- Provides Alaska's boroughs, cities, and unincorporated communities with funds vital to the delivery of basic public services.
- Unrestricted Funds – BUT....must be used for any public purpose that have been determined as a priority of the funding recipient.

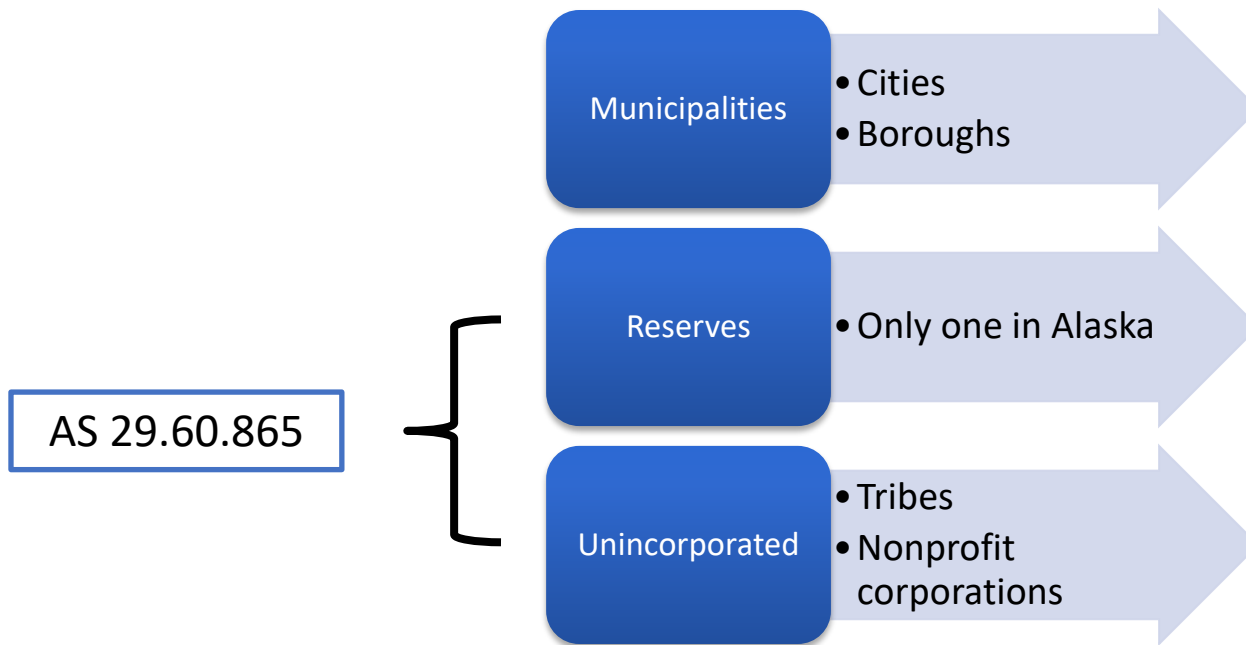
