Black's Law Dictionary Definitions:

Roles: A position or job that has certain expectations that go with them.

Official Responsibilities:

The duties and responsibilities that accompanies one's position in office. It differs from moral responsibility in the sense that more than one individual cannot hold an official responsibility, and it can thus be taken away.



City Council Composition – Voters

AS 29.20.130

Each first-class city has a council of six members elected by the voters at large. Each second-class city has a council of seven members elected by the voters at large. The council of a first- or second-class city may by ordinance provide for election of members other than on an at-large basis for all members.



Legislative Power – Governing Bodies

AS 29.35.010 grants all municipalities general powers (subject to other provisions of law) including powers to:

- establish a municipal department;
- levy a tax, and impose a lien for its enforcement;
- enforce an ordinance and prescribe a penalty for violation of it;
- acquire, manage, control, use, and dispose of real and personal property;
- expend money for a community purpose, facility, or service;
- regulate the operation and use of a municipal right-of-way, facility, or service;
- borrow money;

STATE OF ALA

• provide facilities or services for the confinement and care of prisoners

Executive Power – Mayor

STATE OF ALAC

AS 29.20.220(b)

The mayor acts as ceremonial head of government, executes official documents on authorization of the governing body, and is responsible for additional duties and powers prescribed by this chapter or by home rule charter



Appointment of Officials

AS 29.20.360

Unless otherwise provided by ordinance, the municipal clerk, attorney, treasurer, and police chief are appointed by the chief administrator. Unless otherwise provided by ordinance, an official described in this section serves at the pleasure of the appointing authority and, if appointed by the chief administrator, must be confirmed by the governing body.



Departments

STATE OF ALAS

AS 29.20.400

Departments. (a) The governing body may establish municipal departments and distribute functions among them. (b) Each municipal department is administered by a department head. With the consent of the governing body, the mayor may serve as head of one or more departments, or a single administrator may serve as head of two or more departments.



Organizational Charts

- An organizational chart shows the lines of authority and communication.
- It shows the chain of command within the organization, depicting the supervisory responsibilities, relationships, and flow of information from the governing body through the chief executive to the staff and employees.
- Every organization should have an organizational chart.
- When creating an organizational chart, refer to the ordinances and the policies and procedures manual to determine accurate chain of command.


Role	Responsibility	
Policy Makers	Formulate guiding principles.	
Financial Managers	Budget and oversee money.	
Personnel Managers	Oversee staff.	
Planners	Develop land, economic, and capital improvement plans.	
Utility Managers	Determine services, fees, and rates.	
Lobbyists	Lobby for support or funding from outside sources.	
Ombudsmen	Hear and resolve concerns and complaints.
