



- A written law passed by a legislative body – Bill
- Alaska has 47 Titles
- Title 29: Municipal Government

Bill Process

- The Idea
- Drafting
- Introduction
- First Reading: Referral to Committees
 - Uniform Rule 20
- Committee Consideration
- Second Reading: Receipt of Committee Reports; Consideration of Amendments
- Third Reading: Final Passage
- Time for Reconsideration
- Disagreement?
- Enrollment and Signature

Statutes – Bill Process

DEPARTMENT OF COMMERCE, COMMUNITY, AND ECONOMIC DEVELOPMENT

Role of the Governor

- Action Time!
 - 15 days if the Legislature is in session
 - 20 days if the Legislature has adjourned
- Constitutional Mandate!
 - Sign, Veto, or Not

Bill to Law

- Bill becomes an “Act”
- Given a Chapter number.
- It’s a STATUTE!




Updated annually



Regulations

Written by government agencies to help make sure the laws are being implemented



Regulations

DEPARTMENT OF COMMERCE, COMMUNITY, AND ECONOMIC DEVELOPMENT

Developing Regulations

- Developed by agencies in the executive branch.
- Public Notice when a regulation is proposed.
- Forwarded to the Lieutenant Governor's office for filing and publishing.
- Becomes effective 30 days after being filed by the Lieutenant Governor's office.



