Mertarvik Housing Plan - 2017 Construction Season

Background:

The Newtok Village Council (NVC) is working to construct housing in Mertarvik to allow residents to begin the 'pioneering' phase of their relocation efforts. One demonstration house was built by NVC with technical assistance from Cold Climate Housing Research Center (CCHRC) in 2016. The short-term goal is to build 4-5 single-family homes in Mertarvik in 2017.

NVC has successfully partnered with Housing and Urban Development (HUD), Association of Village Council Presidents (AVCP-RHA) and Bureau of Indian Affairs (BIA) to obtain limited funds for housing units and subdivision roads. NVC has obtained necessary Environmental Assessment (EA) and Findings of No Significant Impact (FONSI) approval from HUD for housing in the town site Phase 1, 2 and Village Center.

NVC desires to use force account / local crews to the greatest extent possible. It is assumed it takes 8 weeks for crews to build each house.

Recommendation/Plan:

- Engage the services of AVCP-RHA to build 4 houses using HUD IT grant and Title VI loan funds. Houses will be of a AVCP-RHA model selected by NVC. AVCP-RHA is a recognized CDBO by HUD and can administer the HUD grant.
- Engage the services of CCHRC to build 1 house, as a training and demonstration model, using BIA Grant funds secured in September 2016. Use the plans and specifications prepared by CCHRC for the 2016 residential demonstration home as the model for unit to be built in 2017.
- 3. Build roads to support house construction; build 15 (5 for 2017 & 10 for 2018) housing pads in the Phase 1 area of town site.
- 4. Work with Alaska Native Tribal Health Consortium (ANTHC) on the development of the community layout and plat.

Budget:

Need approx. \$2.250 M to complete 5 houses.

- 1) Cost per unit
 - a) AVCP-RHA unit estimated cost is \$450,000 (includes site work) (1344 SF)
 - b) CCHRC unit built in 2016 cost \$357,000 (does not include site work) (1152 SF)
- 2) Funding (in hand or imminent) totals \$2.324M:
 - a) AVCP Title VI = \$974,140
 - b) HUD IT Grant = \$900,000
 - c) BIA Grant A16AV01004 (One time only Housing funds) = \$450,000
- 3) Gap may exist for construction of pads to build houses on. This is under review by Design & Construction Team.

Schedule:

- January 2017: Finalize MOA's with AVCP-RHA and CCHRC for 2017 construction work.
- February 2017: Town site plan to 65% level by ANTHC (sufficient to advance additional permitting).
- April 2017: Materials purchased and ready to put on a barge for sailing to Mertarvik.
- o May 2017: Final town site plan by ANTHC.
- o June 2017: Materials arrive on-site.
- o July 2017: House construction begins for CCHRC.
- o August 2017: House construction begins for AVCP-RHA.
- o August 2017: roads and pad construction to coordinate with houses.
- o September- December 2017: Season shutdown.

The Newtok Village Council (NVC) is requesting the services of an architectural and engineering firm in support of the village relocation project. The A/E team will provide professional design services for select activities associated with the relocation effort from Newtok to Mertarvik. Services required may include architectural, structural, electrical, mechanical, civil, estimating, construction administration and other specialties as necessary to complete individual delivery orders. The work on any one delivery order may consist of planning, design and / or construction phase services.

NVC will execute an agreement against the ANTHC Term Contract # ANTHC 12-TC-100040 with LCG Lantech for these design services. LGC will work directly with DOWL, the NVC contracted project manager. Cold Climate Housing Research Center (CCHRC) will serve as a technical advisor for building projects in Mertarvik on behalf of the Newtok Village Council. ANTHC will participate in the project in a design roll, unfunded by this delivery order.

There are several efforts currently underway with a priority in 2017 that may affect the design effort including:

- Mertarvik Evacuation Center shell & core construction: this is the primary task for the A/E.
- Work Force Development
- Quarry Development and Road Design/Construction led by Goldstream Engineering, Inc.
- Housing Development: Complete the construction of four single-family homes. CCHRC completed 1 demonstration home in 2016. The A/E may be involved in the housing project.

There are multiple agencies and consultants involved in the project as a whole and with the four above priorities. The A/E is expected to work collaboratively with the agencies and consultants on behalf of NVC in the development of their scope of work.

The initial **Scope of Work** for the A/E is to complete the design and construction of the core and shell of the Mertarvik Evacuation Center (MEC). CCHRC completed an evaluation of the existing structure and previously ordered materials being stored on-site. CCHRC has made some preliminary design recommendations. (See Exhibit A.) The A/E will pick up the project from the existing point, complete documents of the shell and complete bid ready documents. CCHRC will act as an advisor to the design process. Tasks in the Scope of Work include, but are not limited to:

- 1) Review existing plans, specifications and reports to understand design efforts to date;
- 2) Coordinate with CCHRC on recommendations for completion of MEC shell;
- 3) Prepare design narrative for systems to support MEC, both for shell only and completed structure;
- 4) Prepare Design Development Documents (65%) for shell construction;
- 5) Prepare Construction Documents, plans & specifications (100%) for bidding of contract for shell construction;

Mertarvik Evacuation Center A/E Scope of Work

- 6) Obtain Fire Marshal permit;
- 7) Prepare construction cost estimate for the work.

NVC retains the option to have the A/E work with community on a narrative and concept plans for the build out of the interior of the MEC. Work would include completing interior design with bid ready documents for 2018 construction.

Funding for this project is provided by USACE and various State legislative grants.

The initial agreement will be awarded for a period of 12 months. At NVC's discretion, the contract may be extended one year at a time, for total contract duration of four years i.e., initial year plus 3 option years.

Status Report for Steering Committee

Prepared by DOWL January 10, 2017

Steering Committee last met on December 2, 2016. Since then I want to report on the following:

1) A Design & Construction Team continues to meet on a regular basis for coordination of 2017 activities. The team consists of agencies who have agreements, or contractors that have contracts with NVC for services in 2017. Current members include AEA, ANTHC, CCHRC, Denali Commission, DOWL, GEI, and NVC. We recently added LCG Lantech for the MEC, AVCP-RHA for housing construction and a project manager from Lower Kuskokwim School District.

The team has identified the following gaps that should be immediately addressed:

- a) Need to design a solid waste and sewage disposal site that can be used by residents by the end of 2017.
- b) Need to provide power to the homes planned for construction in 2017. The current assumption is a 'decentralized power system', that is a generator for each house, will be provided to first movers. There may be opportunity for partial use of battery systems in the short term.
- c) Need to provide fuel for residents that will be moving to the community in 2017. We'll engage NNC to see if they have addressed this in any of their plans.
- d) A radio tower or communications link would be beneficial. Cell service is obtainable from the top of a nearby hill, but this is less than desirable from a safety and security perspective.

2) Community Site Plan:

- a) ANTHC has made several trips to Newtok to work with the community on a final site development plan. ANTHC will be in Newtok later this week to advance their work to a point where three options will be developed for community consideration at the end of this month.
- b) ANTHC is working with various agencies that will provide utility infrastructure to incorporate their requests into the proposed site development document.

3) Roads and Quarry Development:

- a) Procurement plan has been prepared and submitted to BIA and SOA for overall procurement of earthmoving equipment and workforce construction housing. Procurement will be a mix of hard dollar bids, negotiated contracts, and request for quotes as appropriate.
- b) HC Construction, as a member of the GEI team selected by NVC, will be leading the force account work in Mertarvik in 2017. As the Construction Manager (CM), HC Construction is tasked with providing field supervision, assisting with equipment selection, and providing dayto-day supervision of construction activities

4) Housing:

- a) NVC has adopted a resolution naming AVCP-RHA as the community based development organization (CDBO), which is a requirement for administrating HUD ICDBG and Title IV funding. AVCP-RHA will administer the HUD IT grant on behalf of NVC.
- b) AVCP-RHA intends to construct 4 houses this summer using Title VI and HUD IT funds. There is some risk with this work, as AVCP-RHA wants gravel pads for the houses in place before they start construction. There is a sequencing issue as house pads cannot be built until the road from


- the quarry into town is complete. We are working with AVCP-RHA to close the timing gap and to insure construction of housing this summer.
- c) CRW Engineering is now under contract to DOWL for the FEMA Buy-out application. The appraiser will be in Newtok the week of 1/9/2017 as part of the application work. DOWL and CRW intend to submit the application to FEMA by February 1, 2017.
- d) NVC was successful in getting the BIA to use a portion of the most recent BIA grant (A16AV01004) for construction of 1 additional house. The community intends to enter into an agreement with CCHRC to build the house in a training and demonstration exercise as they did in 2016.

5) Mertarvik Evacuation Center (MEC)

- a) The Section 221 Integral Determination Report has been reviewed by the Pacific Ocean Division. The Corps Project Manager is revising the Report for Commanders signature and will resubmit for approval. It appears the revising may cause expenditures that pre-date the amendment signing from being eligible as in-kind services that are creditable to the NVC cost-share.
- b) The State of Alaska has approved the use of ANTHC's term A/E (LCG Lantech) for design of the MEC shell. ANTHC has issued a limited NTP to LCG for review of documents and development of a fee proposal for the design effort. NVC and ANTHC will need to execute a MOA to allow use of the term A/E; exact mechanics of the MOA are under development at this time. Design work has not started as of today.
- c) NVC has requested that CCHRC actively participate in the development of final shell design of the MEC on their behalf. The proposal is to issue a new task order under the base NVC / CCHRC agreement for the work and request approval from the State to fund this technical assistance under the same grant that is funding the A/E.
- d) DOWL has been seeking direction from USACE on construction requirements for the MEC to insure compliance with Corps regulations. We have not been successful in obtaining direction as of today.

6) Financial

- a) DOWL continues to revise budgets for the relocation project as new information is provided.
- b) DOWL prepared, advertised and assisted with the selection of a consultant to provide financial services and grants management. Quik Pro Accounting scored the highest and has been notified of the intent to award. Contract negotiations are to begin with NVC on 1/16.
- c) DOWL and BIA met on January 11, 2017 to finalize the financial procedures for NVC. A final document will be provided to all funding agencies once it is approved by NVC.
- d) NVC continues to work towards a payment solution for work performed by CCHRC in 2016. DOWL was assisting with possible use of BIA grant funds, but NVC and their attorney have developed an alternate funding mechanism.
- e) NVC has received tentative extensions of all its grants and GO Bond funds from the State of Alaska. NVC has also responded to Commissioner Hladick, AkDCCED regarding this matter.

DATE OF MEETING: 6 January, 2016

The following topics and issues discussed during the meeting warrant documentation and/or require follow up.

Project Updates

Roads & Quarry (GEI):

- GEI will take the lead on the water rights application. GEI will need to know the flow. ANTHC has sufficient information on the MEC well which has been provided to GEI. GEI will look into the information by the end of January. The other well is located by the airport there is little information on this. ANTHC will provide detail to GEI for the water rights application.
- GEI provided an update on the man-camp and stated that the man camp will be called construction workforce housing (CWH). GEI went to Michigan to look at Construction Worker Housing facilities under consideration for Mertarvik.
 - o NVC will own the CWH.
 - o The CWH will be for 28 people.
 - The CWH should be located near the MEC to take advantage of water & septic systems.
 - o The CWH will have a stand-alone electrical generator.
 - The CWH will take about two weeks to fully set-up.
 - o GEI needs site control for the CWH and the roads from NNC.
 - o Camp cook and camp kitchen.
- GEI provided an update on the Road and Ouarry.
 - o Do we want to use a diesel or electric crusher? AEA stated that both are feasible and Romy and NVC have experience with maintenance for both.
 - The crusher was selected based on a site visit that analyzed materials in the quarry and discussion with the blaster who produced the rock. HC Construction reviewed site and how quarry was opened in making its recommendation on size of crusher.

- Need to plan for the quarry development to have at least two trucks. Redundancy is preferred. If we buy too much, then we can dispose of it. Better to get extra equipment for the entire project.
- o Mark will have the procurement document ready to go by Jan 17th.
- o 30,000 yards will be placed next summer.
- o Shipping needs to be coordinated housing, MEC, road equipment, CWH.
- Need to get inventory of equipment.
- o ANTHC will get GEI costs of helicopter.
- o Get actual inventory in the next two weeks.

Action Items (New)

- Need sample of fuel in 20,000 gallon tank in Mertarvik; determine type and quantity of fuel in the tank. GEI to coordinate with AVCP-RHA staff.
- ANTHC to provide location alternates for placement of CWH near MEC.

Action Items (Old)

- Sierra (ANTHC) will look at field survey notes and find out what documentation is available about the fuel and tanks.
- GEI will work with Glen Price on site control for the CWH and the roads.
- GEI to provide man-camp with preliminary cost estimates by December 15. On the 8th, NVC and the team will pick the best alternative. Then on the 15th, the RFP will be delivered to DOWL, and then will be provided to BIA, Denali Commission and State of Alaska prior to advertising. Advertisement will be on December 29th and bids will close on Jan 16th.

Townsite Development (ANTHC):

- Need ground temperature and depth of bedrock.
- All the geo-tech information is on the website.
- GEI's equipment will include a bob-cat with multi tool capabilities to assist if necessary.

- The earliest for power will be summer 2018. There is a gap between when the houses are built and when the power distribution is in place.

- The assumption that each house would have its own generator. Need to make sure that there is fuel for the generators.
- GEI will also need a large generator for the CWH.
