

**National Forest Receipts Program (NFR)
Borough/Municipality Instructions
FY2021 Application Requirements and Certification**

National Forest Receipts Program regulations (3 AAC 132.050) require all entities that may be eligible for participation in the national forest receipts program (3 AAC 132.040) to submit an annual application including:

- An annual accounting report for State Fiscal Year (SFY) 20 Schools and Roads payment,
- DUNS Number, and
- Certification and Assurances.

Schools and Roads Payment:

3 AAC 132.060. Calculation of national forest within boroughs

The amount of a payment made under the national forest receipts program to each borough will be calculated based upon the area of the national forest located within its boundaries as of September 30 of the state fiscal year immediately preceding the application year.

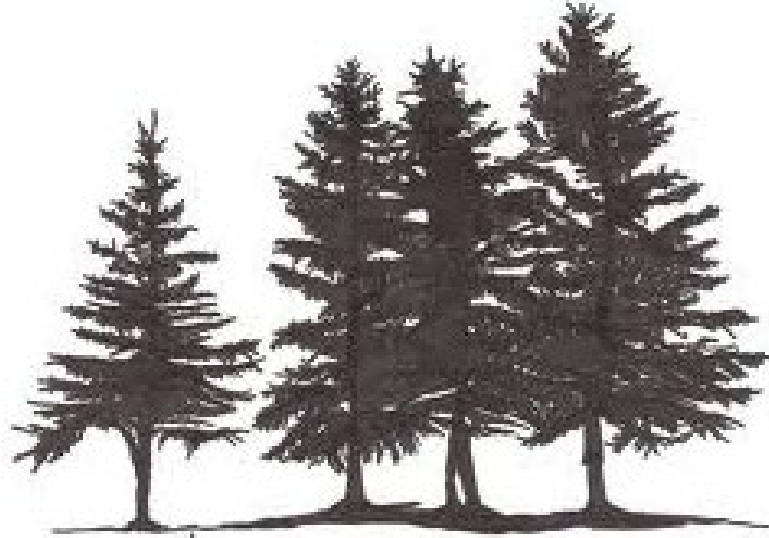
