

The Village Council operates the one central watering point and the Electrical Company. The Village Council is the policy making body for the utilities. Most residents haul water from the new water treatment plant/washeteria and use honeybuckets or outhouses for sewage disposal. The school maintains their own well. A business plan is underway to determine the cost of improvements for a community system.

RUBA Activity This Reporting Period

Ruba staff made one trip to Beaver this quarter. Assistance was provided to the utility clerk by getting ten months of billings out and current and instructions on how to do the PCE Reports. Assistance was then provided to the Tribal Administrator locating state grant files and bringing the grant reports up-to-date. The final day a RUBA assessment was completed. While in Beaver the council had a meeting with VSW and AEA. The first day the council decided on who the project engineer would be and on the second day they met with AEA on the Bulk Fuel Project. Since the RUBA trip, the tribal bookkeeper has resigned. Follow-up assistance has been provided via telephone and fax regarding the electric billing and job descriptions.

Operation of Utility Comments: The community has four certified operators, however, the operation continues to operate on a fly-by-night basis. Although they have a preventive maintenance manual it is not being followed. Things are allowed to fall apart and they wait until the Remote Maintenance Worker comes in to get anything fixed. They do not keep parts on hand for repair. The chief and Tribal Administrator needs to become more proactive to ensure that the operation will continue for years to come. They have a safety manual but do not hold safety meetings; they have a critical spare parts list but don’t maintain the parts on hand. They are on the SNC (Significant Non-Compliant) list for bacteria.
