The Village Council operates the one central watering point and the electric company. The Village Council is the policy making body for the utilities. Most residents haul water from the new water treatment plant/washeteria and use honeybuckets or outhouses for sewage disposal. The school maintains their own well. A Business Plan is underway to determine costs for the improvements needed to provide a community system.

RUBA Activity This Reporting Period

RUBA staff traveled to Beaver to complete a RUBA Assessment of the tribal water/wastewater facility and management of services provided. The tribe requested the assessment as a requirement to receiving Village Safe Water construction funds. The tribe uses QuickBooks Pro accounting for payroll and invoicing and utilizes an independent accounting firm in Fairbanks for assistance in reporting. The tribe provides water service to the school and the washeteria from a surface water source. RUBA staff assisted in establishing a water/wasterwater budget and worked on a draft ordinance for the water/wastewater utility. All essential indicators were met when these were adopted.
