
## Community Overview

The Village Council operates the one central watering point. The Village Council is the policy making body for the utility.

Most residents haul water from the new water treatment plant/washeteria and use honeybuckets or outhouses for sewage disposal. The village provides water to the school. A Master Plan was completed to study system improvements needed to provide a community system. Chalkyitsik has been funded by ANTHC for \$799,690 for water treatment improvements, connecting the school and 10 homes on the West side to piped water and sewer and community watering point. They have also been funded by DEC/VSW for \$192,400 for the Water and Sewer Project, Phase 2 and USDA funded them for Phase 3 for \$405,700.

**Operation of Utility Comments:** The tribe is on the SNC List for Surface Water Treatment and SOC/OOC. They did not do their CCR for the past year. They have a Safety Manual however do not use it. They do not have an Inventory Control or Spare Parts List. They lost their PCE due to non-reporting and non billing for the last six months and are in the process of trying to rectify that issue.

**RUBA Activities For The Coming Quarter:**

Assist the tribal administrator with getting someone trained with QuickBooks and getting the billings out so they can get their PCE back and have revenue to purchase the oil for the generators.
