

The Village Council operates the one central watering point. The Village Council is the policy making body for the utility.

Most residents haul water from the new water treatment plant/washeteria and use honeybuckets or outhouses for sewage disposal. The village provides water to the school. A Master Plan is underway to study system improvements needed to provide a community system.
