The Village Council operates the one central watering point. The Village Council is the policy making body for the utility.

Most residents haul water from the new water treatment plant/washeteria and use honeybuckets or outhouses for sewage disposal. The village provides water to the school. A Master Plan was completed to study system improvements needed to provide a community system. Chalkyitsik has been funded by ANTHC for \$799,690 for water treatment improvements, connecting the school and 10 homes on the West Side to piped water and sewer and community watering point. They have also been funded by DEC/VSW for \$192,400 for the Water and Sewer Project, Phase 2 and USDA funded them for Phase 3 for \$405,700.

RUBA Activity This Reporting Period

One trip was taken to Chalkyitisk this quarter to update the RUBA Assessment and assist with the reports, electrical bills, and QuickBooks Program.

Finances Comments: Financial reports were brought up to date and all outstanding bills were paid. The school had not paid their water bill for over a year. We looked for the MOA/Agreement signed between the tribe and the school and could not find one. I mailed a sample copy for the tribal administrator to get a signed agreement in place so they could start collecting for their water service. The tribe lost their PCE for the electrical company because of non-billing and non-submittal of reports to AEA and RCA. They are in the process of submitting the reports required in order to resume PCE.

Operation of Utility Comments: The tribe is on the SNC List for Surface Water Treatment and SOC/OOC. They did not do their CCR for the past year. They have a Safety Manual however do not use it. They do not have an Inventory Control or Spare Parts List. The alternate operator was in the OIT Training in Minto this quarter.

RUBA Activities For The Coming Quarter: Assist the tribe in getting the necessary training they need to function in the office properly, i.e. Quick Books; Personnel Management; Electrical Billing. Work with the RMW in getting the operators to do their testing; CCR, Inventory Control, and Spare Parts list.
