

Cold Bay Activity Report

Community Overview

Lead RUBA Staff: John Nickels, Anchorage Office

2003 Population: 95

Region: Aleutians

Local Government: 2nd Class City located within the Aleutians East Borough.



City provided services include piped water, piped sewer, landfill, health clinic, dock, fire/EMS/ambulance and a library. The city municipal building includes a fitness center. The new community center is open and provides space for training or community presentations from outside agencies. Currently, water is supplied by one well and stored in a 213,000-gallon tank. The city has applied for funding to dig a second well. The majority of residents are connected to the piped water and sewer system. A few homes have individual wells and septic systems. The sewage treatment plant can process up to 45,000 gallons a day. Residents transport their own refuse to the landfill located 1.5 miles north of the city. A feasibility study is being done to determine whether to clean up or replace the landfill. G & K, Inc. provides electricity to the community.

RUBA Activity This Reporting Period

RUBA staff has been reassigned for this community. RUBA attempted a site visit to complete the reassessment in August. Keeping the RUBA travel budget in mind, the flight to Cold Bay was combined with a flight to False Pass. Unfortunately, the weather turned sour in False Pass and RUBA was unable to leave for several days. RUBA is rescheduling the Cold Bay trip after the regular election and will provide newly elected official training in combination with a reassessment of management capacity indicators. The VSW Engineer George Wilson plans to accompany RUBA staff on this visit.

Finances Comments:

Monthly finance reports, generated with QuickBooks Pro that list the adopted budget, revenue or expenditure, year-to-date revenue or expenditure, and remaining budget for each line item, are provided to the council. The council drafted and adopted a FY05 budget. The council set up an account to place 10% of water and sewer gross profit into a reserve account.

The utility enjoys a very high rate of collections and enforces the collection policy on the rare occasions that make it necessary. The city has adopted the chart of accounts recommended by RUBA.
