

The City of Deering operates the piped water and sewer system, central watering point and water delivery haul system. The City Council is the policy making body for the utility. Water is derived from the Inmachuk River; is treated and pumped to a 400,000-gallon insulated storage tank. Water is delivered to home tanks or hauled from the watering point. Major improvements are completed for their water haul and vacuum sewer system. The new washeteria and water treatment plant project is completed. The City would like to purchase an incinerator with waste heat recovery to reduce the volume of refuse.

RUBA Activity This Quarter

The City of Deering did run out of water for a couple of weeks this quarter and they were able to use run off water from the creek. The Remote Maintenance Worker was able to assist Deering to drain the pipes until they were able to use new water to fill some of the tank. RUBA staff traveled to Deering in June to assist the council and staff with their Village SafeWater application, FY 07 budget, business plan and application for a Community Development Block Grant.

The city had a cash flow problem this last quarter due to the water shortage. They are now three months behind on their electric bills totaling \$18,000. We are working with VSW on equipment, office and house rental to cover the payment of this bill soon.
