The City of Deering operates the piped water and sewer system, central watering point, and water delivery haul system. The City Council is the policy making body for the utility. Water is derived from the Inmachuk River; is treated and pumped to a 400,000-gallon insulated storage tank. Water is delivered to home tanks or hauled from the watering point. Major improvements are under construction for a water haul and vacuum sewer system. A new washeteria and water treatment plant is nearing completion. Archaeological remains were discovered while excavating for the new system. The City would like to purchase an incinerator with waste heat recovery to reduce the volume of refuse.

RUBA Activity This Quarter

RUBA provided training and assistance to the city clerk via phone and fax on how to complete her monthly grant reports for reimbursement. The Kotzebue LGS also provided training and assistance via telephone and fax to the clerk and Mayor on their FY 05 Budget.
