

Hooper Bay Activity Report


Community Overview

The City of Hooper Bay operates multiple watering points, operates a honeybucket haul service and sewage lagoon. The City Council is the policy making body for the utility. Residents currently haul treated water from the washeteria or other watering points. Three new wells were drilled in 1997, 3 miles northeast of town. The school uses its own water system. Honeybuckets are dumped at collection points, then hauled by a 4-wheeler and trailer. Access roads and construction pads are completed. The landfill was expanded in 1997, and includes a new sewage lagoon; the combined site is nearly 20 acres in size. The new water/sewer project construction was underway and the shell of the building itself was completed. Project continues as long as the community meets the grant condition showing capability of financially supporting this project through a sanitation tariff.

RUBA Activity This Reporting Period

RUBA continues to be kept updated with the City of Hooper Bay through documents of the monthly financial reports, copies of IRS/DOL deposit confirmation and 941 reports, administrator's reports, phone calls, and faxed documents. A copy of the FY07 Budget was received by RUBA. The RUBA Agreement has been renewed for another two years by the City and RUBA as of March 2006. This community continues to meet the the special grant condition of maintaining a 75% collection rate through user fee reports faxed to RUBA and Village Safe Water. Constructiton is on-going. Water/Sewer mains are being laid to the pump station. Pipes are becoming a part of the scenery in Hooper Bay. The City burn-box plan is in the design stages before welding takes place. Mr. Murran, City Administrator will be taking time off until second week of July. He certainly deserves this break. Marc Cowart will be acting administrator in his absence.
