

Hooper Bay Activity Report


Community Overview

The City of Hooper Bay operates multiple watering points, operates a honeybucket haul service and sewage lagoon. The City Council is the policy making body for the utility. Residents currently haul treated water from the washeteria or other watering points. Three new wells were drilled in 1997, 3 miles northeast of town. The school uses its own water system. Honeybuckets are dumped at collection points, then hauled by a 4-wheeler and trailer. Access roads and construction pads are completed. The landfill was expanded in 1997, and includes a new sewage lagoon; the combined site is nearly 20 acres in size. The new water/sewer project construction was underway and the shell of the building itself was completed. Project continues as long as the community meets the grant condition showing capability of financially supporting this project through a sanitation tariff.

RUBA Activity This Reporting Period

This quarter RUBA received copies of the City Financial Statement, Monthly Financial reports, User fee collection report, Tax deposit payment confirmations, Employers Federal Liability 941 reports, Copies of the Capital Matching Grant reports and Alaska Contribution Report. The City reported that the end of June sales tax had not yet been received by customers in mid July. The community of Hooper Bay has undergone a devastating loss this quarter. A fire to the elementary school engulfed and spread to the high school and several homes near the school leaving numerous families and teachers homeless. This community continues to meet the special grant condition of maintaining a 75% collection rate through user fee reports faxed to RUBA and Village Safe Water. Construction to the new school for the water connection has been accelerated since the devastating fire occurred. Governor Murkowski made a trip to this community and has declared a disaster for this community. FEMA is now involved in providing assistance. An incident command center has been based in the armory. City of Hooper Bay's VISTA Marc Cowart is the Logistic Chief. Temporary homes are on their way via barges. Debris management is still on-going. Donations have been pouring into this community since the day of the fire from all over. The State of Alaska Payment in Lieu of Taxes (PILT) funds have been awarded earlier than usual due to the fire devastation. This community is hopeful that the school will resume sometime in November 2006.
