

The City Council operates the piped water and sewer system and maintains a central watering point where residents come to haul water to their residences. The City also maintains a sewage lagoon and a solid waste site. The City Council is the policy making body for the utility.

City administration has been busy completing grant applications for renovations for the water/sewer project.

RUBA Activity This Reporting Period

RUBA staff provided assistance via telephone and fax on QuickBooks issues and assisted with the clinic grant. Huslia was awarded funding for a new clinic from the Denali Commission and they are very happy about that. They are working on completing a grant from DCED for the matching funds.
