The City of Kaltag operates the piped water and sewer system. The City Council is the policy making body for the utility.

Piped water and sewer has existed since 1972 in Kaltag. Water is derived from a well and is treated. Most households are fully plumbed. A new 13-unit HUD subdivision was recently connected to the system, and an extension to 6th Avenue is under construction. The City Sanitation Facilities Master Plan is complete. There are needs due to the varying ages of the water/sewer systems, which are addressed in the plan.

RUBA Activity This Reporting Period

RUBA staff and a QuickBooks consultant made two on-site visits to Kaltag as part of QuickBooks training. Staff and the consultant updated accounts, provided instruction on entering checks, transactions, budgets; reconciling bank statements; entering and printing invoices; entering customer payments; printing reports; entering NSF charges; adjusting payroll liabilities; and making journal entries.

Operation of Utility Comments: The utility manager and operator need to work together to make sure that items such as the inventory control list, critical spare parts list, and the monthly O&M reports are done. This needs to be a routine evaluation item. The operator is very capable but routine items need to be addressed and adhered to. The operator provides an oral report to the council. The operator is currently certified to an adequate level.

RUBA Activities For The Coming Quarter

The administrator is doing a very good job. Kaltag is purchasing a new computer and will need assistance setting up the new computer when it arrives. Staff will continue to provide technical assistance and training as necessary. The administrator finds the QuickBooks useful but still maintains the manual system as back up.
