The City of Kaltag operates the piped water and sewer system. The City Council is the policy making body for the utility. Piped water and sewer has existed since 1972 in Kaltag. Water is derived from a well and is treated. Most households are fully plumbed. A new 13-unit HUD subdivision was recently connected to the system, and an extension to 6th Avenue is under construction. The City Sanitation Facilities Master Plan is complete. There are needs due to the varying ages of the water/sewer systems, which are addressed in the plan.

RUBA Activity This Reporting Period

A site visit was made with a QuickBooks consultant. The new computer was installed and the consultant set up the e-mail, QB tax information and all of the rest of the set-up. The City Administrator was provided assistance in completing and setting up the budget. The consultant trained the City Administrator on the new features of the computer, the new QB program and the Monthly Financial Report. I installed the budget sheets on the old computer as well as budget information that was ready for input. I put together the instructions for exporting to the Monthly Financial Report. This was a quick trip and things went smoothly.

Operation of Utility Comments:

The primary operator is still in and out of town and the secondary operator has been maintaining the facility. Water reports are done on time. The RMW reports they do have a preventative maintenance plan developed for existing sanitation facilities but do not follow it completely. They do not have a current CCR, but this was brought to their attention and they will receive assistance from TCC OEH to rectify this.

RUBA Activities For The Coming Quarter

They have had power outages and there are problems with the monitor. The City Administrator will call Gateway to check on this problem. Otherwise, RUBA staff will continue to monitor and respond to problems as needed.
