The City of Koyuk operates the water and sewer system and maintains a central watering point for residents to haul their own water. There are honeybucket pits but no sewage lagoon. The City Council is the policy making body for the utility. A piped water and sewer system was recently completed for the West side of town, serving 51 households. The east loop system is under construction. The school has requested funding to connect to the new sewer system, since its septic effluent is posing a health hazard. DEC has approved the landfill for use, although it is not permitted. Funds have been requested to construct a new water plant and small washeteria.

RUBA Activity This Quarter

Nome RUBA staff is still trying to work with the w/s utility clerk, but the utility clerk is on maternity leave until May, 2005. RUBA was assisting the utility clerk with a w/s utility rate study. RUBA has recommended that w/s residential utility rates be raised gradually over the next 3-4 years from \$45 a month to \$55 a mo., etc., until the rates cover the costs of operating the w/s utility system.

Finances Comments:

The w/s utility and washeteria are still operating in red. The utility used to have a savings account, but the funds were depleted in the last several years because of freeze-ups during winters and the expensive repairs made afterwards. The city borrowed about \$39,000 for fuel oil purchase last year from AEA's Bulk Fuel Revolving Loan Program and has had trouble making payments. In fact, the city has not made any payments because of financial problems.
