The City of Koyukuk operates the central watering point at the washeteria and residents haul their own water. The City also maintains honeybucket pits and the sewage lagoon. The City Council is the policy making body for the utility.

Residents haul treated well water from the washeteria and use honeybuckets or pit privies. Households are not plumbed. The school and washeteria use City water, with sewage disposal into a lagoon. A Master Plan is underway, and preliminary work has begun to upgrade the community to a flush/haul system. A new landfill and access road are under development. There are five households on the honeybucket haul demonstration system, which is paying for itself.



RUBA Activity This Reporting Period

RUBA staff maintained contact with Koyukuk City staff answering routine questions and requests for assistance on a variety of matters. RUBA staff attended the FEMA meeting at TCC who is the recipient of the FEMA funds for the relocation study. The City Administrator was set to attend the Utility Management Financial Management weeklong training held in Fairbanks and was not able to attend due to weather.

Operation of Utility Comments: The City operates a washeteria that is very old. They do an excellent job of maintaining what they have. RMW was recently in Koyukuk and trained the operators in maintaining the washers and dryers, all of which are now up and running. They have spare parts and equipment for the plant they do have. DEC reports they are on the Significant Non-Compliance List for VOC and nitrate. This has been discussed with the manager.

RUBA Activities for the Coming Quarter

Tentative travel is scheduled to work personnel issues with the Council. We will continue to address issues on the proposed relocation and FEMA issues. Continue monitoring and continue to assist as the need arises.
