The City of Koyukuk operates the central watering point at the washeteria and residents haul their own water. The City also maintains honeybucket pits and the sewage lagoon. The City Council is the policy making body for the utility. Residents haul treated well water from the washeteria and use honeybuckets or pit privies. Households are not plumbed. The school and washeteria use City water, with sewage disposal into a lagoon. A Master Plan is underway, and preliminary work has begun to upgrade the community to a flush/haul system. There are five households on the honeybucket haul demonstration system, which is paying for itself.

RUBA Activity This Reporting Period

There are still problems, however, the city has been able to have a meeting and another one is scheduled. The special election was set, however, was not held due to the fact that no one signed up. I discussed this with the City Administrator and will provide her with more information on this. The new furnace has been installed. The budget was submitted and the PILT resolution was submitted. Trips were scheduled to Koyukuk but were not able to be completed due to weather conditions beyond Galena. The new washers are in, unfortunately the new coin boxes are not in yet. The honey bucket haul system is not working well. The skis for the haul system buckled and there is no reasonable way for anyone to do the hauls. In part the problem has to do with the very heavy snowfall this year. Financial records are being kept by hand. They still need a CCR.
