

Manokotak Activity Report

Community Overview

The city operates two water/sewer systems in Manokotak, one at the village site and another at the Manokotak Heights area. Water is derived from two wells, is treated and stored in a 150,000-gallon water storage tank. A piped water and sewer system, constructed in 1972, serves 68 households and the school with complete plumbing. Two homes and a duplex have individual wells. Manokotak Heights, located 4 miles to the south, is served by a well and treatment system, but water shortages have occurred. New HUD housing units were built in 2000, and additional units are planned. The school, located in the Heights area, operates its own water and sewer system serving the school and one teacher housing unit. A feasibility study to examine water, sewer and landfill improvements was completed in late 2004.

RUBA Activity This Quarter

Dillingham Regional Office RUBA conducted a RUBA assessment of the City's water-sewer utility in December 2004. The assessment, a VSW special grant condition, identified deficiencies and offered recommendations for improvement. The City, in conjunction with VSW, is in the process of planning a community-wide piped water and sewer system renovation. The utility does not meet all of the Essential Capacity Indicators and continues to actively address deficiencies. RUBA offered assistance on a monthly basis and provided other technical assistance to the city including grants management, planning, compensation and general government recommendations. The city reportedly adopted an improved water/sewer ordinance; this event indicates progress in their continued efforts to resolve assessment recommendations.

Finances Comments:

RUBA awaits confirmation of an amendment of the water/sewer budget RUBA suggested the production and presentation of a monthly written report for city council meetings identifying year-to-date budget and actual expenditures, collection rates, water testing update, and any other managerial and financial information. RUBA offered to provide input into the city administrator's development of a more comprehensive chart of accounts and awaits a response.

City staff appear proficient with Quickbooks and should consider implementing Accounts Receivable and Accounts Payable reporting to resolve recommendations.

Operation of Utility Comments:

The city must develop a preventative maintenance plan for the water/sewer utility including a critical spare parts and inventory control list. The Operator is in contact with BBAHC RMW staff and should consider seeking assistance from the VSW engineer. The city's water/sewer utility is listed on the February 2005 SNC list and is reportedly working toward first quarter compliance.

RUBA Activities For The Coming Quarter

The City of Manokotak continues to actively address assessment recommendations. The city reportedly reviewed and adopted an improved water sewer ordinance; RUBA awaits confirmation. A comprehensive and clearly written ordinance may go far to address several assessment recommendations. RUBA staff will continue to offer assistance to the city and will plan travel to the community in the second quarter.
