

# Marshall Activity Report

## Community Overview

2002 Population: 364

Region: Yukon Delta

Local Governments: Second Class City



Water is derived from two wells. Two wells were completed in 1991. Approximately 70% of the City (60 homes) are served by a piped circulating water and sewer system and have full plumbing. The remainders haul water and use honeybuckets. The remaining unserved 19 homes and the fish processing plant, have been completed of the system installed in the late 1970s. A new landfill and access road were completed in 1997, and the City has begun a refuse collection service.

## RUBA Activity This Quarter

RUBA staff has been providing most of the assistance over the phone, fax and email to the community this quarter.

RUBA staff met with the city council and staff members on several items that needed to be addressed by the city.

The Clerk has been working with QuickBooks over the past several years and has become very knowledgeable with using the program. RUBA staff made recommendations to the council members to hire a QuickBooks consultant to help the Clerk with some minor problems with the QuickBook program.

The Council passed their organizational chart and Personnel policy for the city.
