


Mekoryuk Activity Report

A Memorandum of Agreement has been signed between the City and Native Village of Mekoryuk/IRA for operation and maintenance of the utility. The tribe is going to run the utility and is in transition of taking over the utility operation and Maintenance. The city and tribe are still in discussion stage as to what the MOA means to both entities.

RUBA Activity This Quarter

There has been a change in the city and tribal administration and as a result this has affected the integrity of the monthly financial reports. As with any turnovers, the new administration is having to figure out where the previous administration left off and where to begin. The tribal bookkeeper resigned and they hired a new bookkeeper. The MOA is being reviewed by the tribe to see what has worked and the question will be put to both councils whether to renew the MOA in January of 2006. The City clerk resigned and they hired a new clerk. The outgoing city clerk helped the new clerk in the transition.
