The City of Nightmute provides a small water facility, which is the central watering point for residents to haul their own water. The City also provides water and sewer haul service. The city utility system has 37 residential units, 5 commercial/residential and 6 commercial units. The school has its own sewage lagoon. A washeteria is not available. The Nightmute Power Plant was acquired by AVEC in March 1998. Electricity is provided by AVEC.

RUBA Activity This Reporting Period

The City of Nightmute does not have an administrator or bookkeeper, instead they have a working mayor. The mayor is utilizing the gaming bookkeeper(s) to also do the city accounting. This is due to budget cuts that have been made. RUBA staff provided samples of a chart of accounts and financial reports and will continue to provide assistance when requested.

Finances Comments:

The FY05 budget has been started, but has not been completed yet. Their FY03 CFS has been completed and sent in to Juneau along with the PILT Resolution. There has been no Monthly Financial Reports forthcoming from the city since the last administrator resigned for health reasons in the family. She had been trying to follow her budget, but in her absence financial management had been degrading to a point of requesting contributions from the gaming account to subsidize some of the utility parts purchases. The council needs to understand financial management and budgeting if they are to understand the consequences of how they are spending money.

Operation of Utility Comments:

The utility has been having equipment problems; the snowmachine is out now needing parts. There has been no water hauling done for a month due to a broken wheel on the water haul tank. The ordered parts arrived, but the wheels of wrong size. They could not return the wheel for replacement because they either misplaced the invoice or lost in the files.

RUBA Activities For The Coming Quarter

The RUBA staff will continue to request monthly financial reports in order to complete the assessment of their financial status. The City loaned money to the corporation store and there has been no payback of the loan to date. RUBA will work with the City to enforce payback of the loan. The last RUBA agreement with Nightmute was signed in 1996. A new RUBA agreement will be requested.
