The City Council is the policy making board for the utility. They operate the Water Treatment Plant and central watering point, sewer haul and washeteria. There are several sewage bins located around the village and these are emptied with carriage trailers. Village has plans for a piped water and sewer system.

RUBA Activity This Reporting Period

Ken completed a RUBA assessment update with Carin Finch, City Advisor, which she approved and I send the report to Scott Ruby, my supervisor, Carin Finch and Matt Dixon, ANTHC engineer.

Carin Finch called and informed us Nunam Iqua was almost out of gasoline but okay with stove oil. Also said Alakanuk is in the same situation and Emmonak is rationing at five gallons per day. If they fly in fuel it will cost upwards to \$12 per gallon. I relayed the message to Scott Ruby. Carin said the City needs about 200 gallons to run the sewer haul until first barge arrives.

Organizational Management Comments: The City owns and operates the water plant, washeteria and sewer haul system. The City is the policy making body for the utility. The 2004 budget is adopted. The City is active in making policy for the utility. The City Administrator is also the Utility Manager and has years of experience and also attended a Utility Management Workshop. The utility has adequately trained operators. The main operator is certified with Water Treatment Level II, Water Distribution Level I, and Wastewater Collection OIT. The City has adopted a utility ordinance that gives it the authority to operate, and it covers most of the aspects needed in a utility ordinance. Along with a collection policy, the ordinance includes policies on service area, level of service, customer agreements, the utility's responsibilities, the customers' responsibilities, billing procedures, shut-off procedures, and penalties for violating provisions of the ordinance.
