Community Overview

The City of Nunapitchuk operates the washeteria, water treatment plant, garbage collection, container haul system, and the flush haul system for the community. The utility services provide water deliveries and septic haul-out to residential customers connected to the flush haul system. Those not connected to the flush haul, utilize the container haul system.

Currently, there are 91 units in operation, with 4 more units projected for construction. These should be done by early Spring 2003. Remaining households not in the flush haul system, deliver their own water and empty honey-buckets to bins located sparingly. Sewage containers are located throughout the City, and are emptied into one of two new sewage lagoons (one on each side of the River). The City provides piped water to the school. Teacher's housing, located in the old school, has an independent water and sewer system that still needs improvements.



RUBA Activity This Reporting Period

RUBA staff presented the RUBA Program/Process to the City staff, review the preventative maintenance schedule and the assessment process, train on the rate analysis procedures, and review the utility management components.
