

The City of Nunapitchuk operates the washeteria, water treatment plant, garbage collection, landfill/lagoon, and the flush haul system for the community. The utility services provide water deliveries and septic haul-out to residential customers connected to the flush haul system. Those not connected to the flush haul, utilize the container haul system.

Currently, there are 124 Flush Haul units in operation. Out of the 46 units slated for construction, 44 units were plumbed, as two households refused service. Remaining households not in the flush haul system deliver they're own water and empty honey-buckets to bins located sparingly in the community. Sewage containers are emptied into one of two new sewage lagoons (one on each side of the River). The City provides piped water to the school. Teacher's housing, located in the old school, has an independent water and sewer system that still needs improvements. Preliminary plans are underway for a second water treatment plant for the other half of the community located on the other side of the river, and another plan for filling old sewage bunkers and lagoons.

RUBA Activity This Reporting Period

Provided utility management training assistance to the principle engineer assigned to the community. VSW is planning to setup utility management training on behalf of the City of Nunapitchuk with the RUBA Program staff providing the instructions.

Finances Comments: The City has a \$25.00 per service rate for its water deliveries and septic haul-outs, this is not sufficient, but they are planning to conduct a utility rate analysis now that majority of the households are connected to the flush haul system. An educational presentation will be presented once new rates are recommended.
