IMPORTANT:

WHAT IS A DOMESTICATION?

Domestication (moving from a different jurisdiction or home state to a new jurisdiction or home state) means a transaction authorized by AS 10.55.501-10.55.506, with the exception of the entities excluded under AS 10.55.110. Under this:

- A domestic (Alaskan) limited partnership may become a foreign (non-Alaskan) limited partnership in a foreign jurisdiction if the domestication is authorized by the law of the foreign jurisdiction.
- A foreign (non-Alaskan) limited partnership may become a domestic (Alaskan) limited partnership in this state if the domestication is authorized by the law of the foreign entity's jurisdiction of organization.

ITEM 1: Provide the domesticating (moving from) limited partnership name, the Alaska Entity Number (if applicable), and the jurisdiction (home state moving from). (Note: the entity type in Item #1 must match the entity type in Item #2.)

- A limited partnership name must be distinguishable upon the record. To search the availability of the legal name of the corporation in the State of Alaska go to the above website, click License Search, and select Search Corporations Database.

NOTE: the name of the limited partnership in Item #2 on the Statement of Domestication must match either Item #1 on the Certificate of Partnership or Item #1 on the Certificate of Registration attached to this filing.

The registered agent information may only be updated via a Statement of Change Registered Agent form. The non-refundable filing fee for a Statement of Change is \$25. The Statement of Change may be filed in conjunction with this Statement of Domestication. The form can be found online at the above website select Forms and Fees.

Do not send both together. Submit <u>either</u> the Statement of Domestication **OR** the plan of domestication that is signed on behalf of all entities and contains all the information required to be in the Statement of Domestication and is delivered to the Division for filing after the plan has been adopted and approved by all merging entities. Sending both the plan of domestication and the Statement of Domestication together may cause delays in processing time.

IMPORTANT: Changing Officials

<u>If</u> the Statement of Domestication results in the change of an official, officer, director, shareholder, member, manager and/or percent owned <u>then</u> the domesticated (moving to) entity (listed in Item #2 on the Statement of Domestication) <u>must</u> file a notification of changing officials with this division.

- A Notice of Change of Officials must be filed in the manner and time prescribed in AS 10.06.813, 10.20.631, 10.50.765, or AS 32.11.020(d).
- In the case of a Limited Partnership: a domestic Limited Partnership must file an Amended Certificate of Limited Partnership and for a foreign Limited Partnership must file a Certificate of Correction in the manner and time prescribed in AS 32.11.020(d).

The appropriate form can be found online at the above website and select Forms and Fees. The notification form may be filed in conjunction with the Statement of Domestication. The filing fee is \$25.
