The board adopted the following draft regulations:

12 AAC 36.068(a)-regarding landscape architect registration by exam.

12 AAC 36.100(d)(1)-changing the name of the land surveyor exam to Principles and Practice of Surveying.

12 AAC 36.111-practice of land surveying.

12 AAC 36.115(b)-regarding retired status registration.

12 AAC 36.135-repealing the requirement for a certificate from Corporations for firm registrations.

12 AAC 36.400-450-continuing education for surveyors.

12 AAC 36.061(a)(2)-NCARB education standard.

The board will not be adopting regulations for courtesy licensing. 06/20/06

Regulations Approved for Public Notice

The board approved for public notice changes to 12 AAC 36.040, .050 and .070 to allow for the ELSES administration of the NCEES FS/PS and FE/PE examinations. ELSES will begin administering the NCEES exams in October 2006.

Legislative Recommendations

- Change name of Board to Board of Registration for Architects, Engineers and Surveyors (deleting "land").

What's New

The Board adopted a board policy requiring that the date on stamped plans be within two inches of the stamp.

The Board approved an administration of the Alaska Land Specific (AKLS) exam for October 27, 2006 because of the number of interested persons. The

Disciplinary actions from the year 2000 forward are now posted on the board's web site and will be updated continually.

Other Updates

ELSES Administration of NCEES Examinations.

Because NCEES exam administration has been turned over to ELSES, exam fees have increased as follows:

FE - \$190

PE - \$270

FS - \$205

PS - \$270

Exam candidates will pay a nonrefundable \$50 application fee to the division, but exam fees will be paid directly to ELSES. There is no fee to request a retake of a failed exam, but the exam fee must again be paid to ELSES.

AELS staff will continue to administer the AKLS exam.

Board Position on 30 post graduate credit hours for engineering.

The board does not support the NCEES' recommendation that persons holding an ABET accredited degree be required to earn an additional 30 post graduate credit hours to be eligible for the NCEES exams. The board feels an alternative is to charge ABET with increasing the number of hours required to earn the accredited bachelor's degree in engineering.

Applicant Files Reviewed

At its May 2006 meeting the board reviewed and approved or conditionally approved 52 applicants for registration by examination or comity. The board also approved one applicant for the FE exam and one applicant for the FS exam. Eight applications were found to be incomplete and will be re-reviewed at

the August 2006 meeting upon receipt of additional documentation.

One application was denied.

AELS Deadlines/Exam Information

Effective immediately the deadline for "complete" applications for registration by comity and "complete" applications for the FE/PE and FS/PS exams will be receipt in the *Juneau Office* at least 10 days prior to the next board meeting.

THERE WILL BE NO EXCEPTIONS TO THIS DEADLINE.

The next board meeting is tentatively scheduled for August 17-18, 2006 in Anchorage. The meeting will be held in the Atwood Building, 550 West 7th Avenue, Room 1270. Application deadline is receipt in the Juneau office 10 days prior to the meeting.

NCEES exam retake requests:

In order to be approved to retake a failed NCEES exam in October 2006 written requests must be received in the Juneau office no later than September 1, 2006. In order to be approved to retake a failed NCEES exam in April 2007 written requests must be received in the Juneau office no later than February 20, 2007. The October 2006 FE/PE, FS/PS and AKLS will be held on October 27-28, 2006 in Juneau, Anchorage, and Fairbanks. Locations are not yet known.

<u>Landscape Architect Registration Exam</u> (<u>LARE</u>): October 3, 2006 is the retake request deadline for Sections C and E for the December 4-5, 2006 LARE exam administration.
