






DIVISION OF CORPORATIONS, BUSINESS AND PROFESSIONAL LICENSING

Letters of Advisement constitute a caution on behalf of a Board or program. They are usually employed when the violation detected is very minor or it is a first offense and the Board/Commission or program wants to give the licensee a warning, but not engage in public licensing action. These letters are distinctly “non-disciplinary” and not public; therefore the identities of the licensees who received these cautions is marked confidential.
