**MINUTES OF MEETING
July 20, 2015**

By the authority of AS 08.01.070(2) and AS 08.86.030, and in compliance with the provisions of AS 44.62, Article 6, a scheduled teleconference meeting of the Board of Barbers and Hairdressers was held July 20, 2015.

These minutes were drafted by staff of the Board of Barbers and Hairdressers and have not been reviewed or approved by the Board.

Monday, July 20, 2015

Item 1. Call to Order/Roll Call

The meeting of the Board of Barbers and Hairdressers was called to order by Glenda Ledford, Chair at 3:02 9.m. Members present were:

Item 2. Discuss Dept. of Environmental Conservation (DEC) Shop Inspections (12 AAC 09.110).

Sara Chambers outlined that beginning July 1, 2015 DEC no longer issued shop inspection certificates/inspection reports to shops providing hair and facial services. Ms. Chambers informed the Board that there are currently at least ten (10) pending shop owner applications that have been effected by this change.

Ms. Chambers stated that a self-certification signed and notarize by shop owner applicants certifying that a shop was in compliance with DEC Hair and body Art Schools and Shops requirements, 18 AAC 23, and a resolution to change the Boards current requirements of 12 AAC 09.110 to accept a self-certification would allow staff to process shop owner applications until the Board could discuss this issue in more detail during its October 5, 2015 meeting with the Department of Law.

The Board expressed concerns that this would add to the workload of staff and that they felt this should be addressed by DEC as shop inspections are in their Statutes.

Deanna Pruhs asked Ms. Chambers when did DEC provide notification that they were no longer providing shop inspections. Ms. Chambers responded that DEC had provided notification the week before July 2015.

The Board discussed costs, alternate options and reviewed the two resolutions drafted by Ms. Chambers at the suggestion of Assistant Attorney General Signe Anderson.

On a motion duly made by Derrick Slaughter, seconded by Deanna Pruhs, it was

Whereas the Department of Environmental Conservation (DEC), Food Safety & Sanitation Program, ceased to provide inspection and certification of barbering and hairdressing shops and schools as of July 1, 2015;

Whereas this certification is required for licensure under Board of Barbers and Hairdressers regulation 12 AAC 09.110(a)(7); and

Whereas new shops and schools are unable to become licensed as of July 1, 2015, because the requirements of 12 AAC 09.110(a)(7) cannot be legally met, causing small businesses to be unable to operate and to deprive licensed barbers and hairdressers of gainful employment;

RESOLVED that the Board of Barbers and Hairdressers will accept the following documentation in lieu of the DEC or municipal certification required in 12 AAC 09.110(a)(7): a statement signed and notarized by the applicant under penalty of unsworn

falsification that the shop is fully in compliance with the environmental sanitation regulations in 18 AAC 23.

Ms. Ledford asked the Board if they would like any further discussion on this motion; hearing none, Ms. Ledford asked for a roll call vote.
