Glenda Ledford requested new Board member Jessica Steele introduce herself.

Ms. Steele greeted the Board and gave brief background. The Board welcomed Ms. Steele.

The Board reviewed ethics disclosure forms in the meeting packet.

THE MOTION PASSED UNANIMOUSLY.

Ms. Ledford and Deanna Pruhs gave a brief overview regarding how the legislation, House Bill 131, came to be and why the Board felt changes in manicuring regulation were needed. Ms. Ledford stated concerns for the public safety due to poor sanitation, lack of education for service providers, not being able to reciprocate Alaska's manicuring license to other States and having the lowest licensing requirements in the Nation were the driving factors behind the legislation and currently proposed regulations.

Ms. Ledford stated that no public comments would be accepted during this teleconference. Ms. Ledford went on to state the public comment period had ended December 18, 2015 at 4:30pm.

Ms. Ledford also provided a brief synopsis of renewal requirements for currently licensed manicurist:

To renew a current manicurist license for the 2017-2019 biennial cycle will require licensees provide proof of 250 hours of work experience and pass the National Nail Technician written exam.

Ms. Spencer added that by August 31, 2019 currently licensed manicurist will need to complete 250 hours of school or 300 hours of apprenticeship training, apply for the new Nail Technician license and if they haven't already pass the National Nail Technician written examination.

Ms. Ledford also stated that individuals who have completed 250 or more hours and passed a written examination to qualify for a manicurist/nail technician license in another State would be able to provide that documentation to licensing staff and obtain the new Nail Technician by waiver of exam/credentials/reciprocity.

Item 4. Adopt Regulations

Harriet Milks-Dinegar, Attorney, informed the Board that they must also state on the record costs to the public had been taken into consideration.

Ms. Ledford asked the Board if they had taken into consideration costs to the public these regulations may cause. The Board responded they had taken costs to the public into consideration.
