70 **Investigations:**

71
72 After a brief break, Ms. Lombardo brought the meeting back to order. The board investigator, Dawn
73 Bundick joined the meeting to present the board with the investigative report for Jun 16, 2018 through
74 September 15, 2018. She reported that the Division opened six matters, and closed five. Thirty-three
75 matters remain on-going and under active investigation or are pending litigation and/or Board action.
76 The Division conducted 37 license compliance checks.

77
78 Probation Monitor, Katrina Medina reported that all licenses that are in probation status are in
79 compliance, except 4 individuals that the board is already aware of. Each of these individual cases were
80 discussed by the board.

81
82 Chief Investigator, Greg Francois provided the board with what he believes will be needed to support
83 the requirements of inspection from Senate Bill 4. He is proposing that the Division hire 2 new
84 investigators that will be dedicated, along with Ms Bundick to take on the heavy lifting of inspecting
85 salons starting January 1st 2019. Since salons have not been inspected by DEC since 1995, the initial
86 implementation could be a substantial amount of work for the investigative team. The board
87 understood that the addition of staff and travel could result in license fees going up. Ms. Bundick will
88 meet with DEC this month to continue to research the inspection requirements and how her team will
89 be able to meet the expectations as laid out in SB4. Chief Francois explained that each inspections,
90 especially in the initial stage, will be its own complex situation. The board requested that once the

91 requirements are set, that staff send them out to all shop owners and post them on the board's
92 website. The board believes that providing this information to the public and the stake holders ahead of
93 time will increase compliance from the industry.

165 **Continuation of the Investigative section:**

166

167 Board Chair, Jennifer Lombardo brought the meeting back onto the record after a break. The board
168 requested that, due to a time limit earlier in the morning, Chief Investigator, Greg Francois rejoin the
169 meeting at 3:00 pm to discuss the difference between an advisement letter and a closure letter. Chief
170 Francois provided the board with examples of each. He explained that an advisement letter is sent out
171 to an individual that needs to be informed that they are working outside of the law, this is a non-
172 disciplinary letter. Whereas a closure letter is used once an investigation has been completed and is
173 closed. Board member Michelle McMullin suggested that the advisement letters come with a small fine.
174 However, it was discussed and decided that this invalidates the advisement letter and changes it to an
175 action.

176

177 Board investigator Dawn Bundick also reviewed the disciplinary matrix with the board. She was able to
178 clarify for the board and staff that the matrix dated October 6th 2014 is valid, all others are not
179 outdated.

180

181 **Public Comments:**

182

183 At 3:30 pm, Ms. Lombardo opened the meeting up for public comment. There were no public members
184 on the telephone line and 1 licensee in the room.

185

186 Charles Watson: Mr. Watson is a licenses body piercer in Alaska. Mr. Watson encouraged the board to
187 hold individuals accountable for working outside of the law. He also stated that, in his opinion, the
188 board will get “blow back” from the public if fee do go up to accommodate the new inspection
189 requirements brought on by SB4.

190

191 The board thanked Mr. Watson for his comments.

Review the Agenda:

The board reviewed the approved agenda.

Regulation Project Review:

Hearing no concerns about the day's agenda, Board Chair Jennifer Lombardo welcomed Regulation Specialist Sher Zinn via teleconference. Ms. Zinn provided the following information to the board for consideration regarding their current regulations project in light of SB4:

Items located that will cleanup barber and hairdresser regulations- added to current project:

1. 09.002(g) and (h). Repeal of application fee for student permit, other student permit regulations do not have the application fee. We have never charged or received application fees for student permits, only the permit fee.

The board agreed that this is the best practice

2. 09.002(w). Added checklist regulation for manicurist. This was not added back when the manicurist regulations reverted to pre 2016.

The board agreed that this is the best practice

3. 09.056(b)(2). Added 100 grade points for each of the two practical portions of the exam, which is in the other practical exam regulations. Does the board want to mirror haircutting, hair styling, and drying portion of the practical exam found under the barber exam in (a) of this section? If so, the board can use the score sheet for the barber exam and just remove the portions of the barber exam that are not used. See 09.056(a)(2)(D).

The board agreed that this is the best practice

Items for board consideration and discussion:

1. AS 08.13.160(f) A person licensed under this chapter to practice hairdressing is considered to be licensed to practice manicuring, **hair braiding**, and limited esthetics under the same license. This does not give barbers the authority to practice hair braiding. Therefore, barbers may not be able to perform hair braiding or teach hair braiding without a hair braiding license. Confirmed by Harriet Milkes 9/18/2018.

267 Ms. Zinn directed the board attention to AS 08.13.160(f) and explained that the current statute does not
268 include licensed barbers in concerns to the ability to hair braid. Kevin McKinley stated that this is
269 definitely an unintended consequence of the statute. Shawn Idom stated that starting January 1, 2019
270 all barbers will need to obtain a hair braiding license in addition to their barbering licenses. He also
271 stated that the board will purpose to Legislators that this oversight must be corrected. The board
272 requested that staff send out a mass email to all licensed barbers notifying them of this change in
273 requirements.

274

275 *2. New statutes do not allow for a student permit for a hair braiding training. AS 08.13.180,*
276 *student permits, hair braiding not added. Harriet Milkes confirmed*

277

278 **In a motion duly made by Shawn Idom, seconded by Terriann Shell with a roll call vote, it was**
279 **resolved to amend the current regulation project and add “hair braiding” to 08.131.180.**

280

281 **Motion rescinded by Shaw Idom as the board does not have the authority to change statutes**

282

283 After further review, the board came to the concluding that no changes are needed for this topic

284

285 *3. 09.107. Added non-chemical barbering and hair braiding to temporary permit.*

286

287 The board reviewed and agreed to this change

288

289 *4. 09.115. Added non-chemical barbering and hair braiding to verifications.*

291 The board reviewed and agreed to this change

292

293 *5. 09.095. Board needs to determine combination of coursework and work experience for nonchemical*
294 *barber, as they have for barbers and hairdressers.*

297 **resolved to add 1 year work experience, with no less than 32 hours per week at a license**
298 **barber shop, and a minimum of 1200 hours training in an school or apprenticeship program**
299 **approved by the board or by another licensing jurisdiction that meets or exceed Alaska’s**
300 **requirements to 12 AAC 09.095(c) and add at least 2 years of full time work experience at a**
301 **licensed barber or hairdresser averaging no less than 32 hours per week and a minimum of**
302 **800 hours training in an school or apprenticeship program approved by the board or by**
303 **another licensing jurisdiction that meets or exceed Alaska’s requirements to 12 AAC 09.095(d)**
