### Agenda Item 4 SB 69

Chair, Dr. Heston moved to discussion on Senate Bill 69, wherein several statutes have been amended to expand the chiropractic regulatory board and its profession by incorporating oversight and employment of interns, preceptors, and clinical assistants. SB 69 also clarifies pre-participation physical examinations within the scope of chiropractic practice, and adds language to the Board's advisory committee, among other changes.

The main reason for the teleconference was to establish the Board's resolution to support SB 69 before the end of session. Dr. Barrington asserted that he had contacted Senator Stoltze's office, at which point he learned that the bill had been sent to legal because a change of language was needed in order to remove a fiscal note. Dr. Barrington expressed that at present, the bill would not be passed during this year's session. Dr. Heston commented that it would still be a good idea for the Board to express their support on record, to which Dr. Campbell agreed.

Dr. Barrington added that the change of language is being made in an effort to remove the fiscal note that would otherwise mandate the Board to be monetarily responsible for covering clinical assistant certification fees by external testing entities.

Ms. Carrillo prepared a ballot illustrating the favor of the Board to support SB 69.

On a motion duly made by Dr. Barrington seconded by Christine Hill, and approved unanimously, it was

RESOLVED to approve and sign the ballot regarding SB 69 as written.
